This quote is inspirational and provides insight into my thoughts of our past calendar year; more importantly, it serves as the foundation for our work moving forward. Overcoming the challenges of last year simply serves as a reminder of what we can accomplish when we mix equal parts, strategic thinking, compassion, and resiliency to execute the mission. Our theme for this upcoming year is "Defying the Odds" and these are not hollow words, they represent a movement.

We will continue to take bold and aggressive action for the survival of River Rouge Public Schools and I can promise you that the services provided to your children this year will match the bravado in which we speak. We are thankful for you entrusting us with your most precious asset and you can rest assured our efforts to improve will exceed your expectations.

While our most recent efforts were able to bear fruit, it is with great sadness that I mention two urban communities with similar demographics as our own no longer having the luxury of a local school district to operate. I use luxury in the most literal sense as the promises of our past are no longer guaranteed for future generations, regardless to geographic location or zip codes. The boundaries for those districts have been redrawn and the children have been dispersed to neighboring districts.

The real tragedy in this situation comes from the fact there is little guarantee, if any, that the receptions awaiting those students will be as nurturing as their own communities were to them. Furthermore, the misfortune caused by the loss of tradition, history, and the unknown for those students, employees, and communities of both Inkster and Saginaw Buena Vista will have devastating outcomes

## MICHIGAN'S "STAND YOUR GROUND LAW"



In the wake of George Zimmerman's acquittal and the subsequent outrage from the community and organizations such as the NAACP, calling for justice in the death of Trayvon Martin, maybe its time to take a second look at he law. Some members of the Michigan Legislature are saying just that. In 2006, Michigan enacted the Self Defense Act, otherwise know as "Stand Your Ground" law, found at MCL 780.972. The law states:

780.972 Use of deadly force by individual not engaged in com-

mission of crime; conditions. Sec. 2.

(1) An individual who has not or is not engaged in the commission of a crime at the time he or she uses deadly force may use deadly force against another individual anywhere he or she has the legal right to be with no duty to retreat if either of the following applies:

(a) The individual honestly and reasonably believes that the use of deadly force is necessary to prevent the imminent

The outside of the building said Wayne Regional Educational Service Agency, but the building had the feel of a funeral home.

Many Inkster residents came to

see Inkster Public Schools officially declared dissolved and dead this past Thursday. And like a funeral, there was much sadness, shouting and outrage.

RESA Superintendent Christopher Wigent said that it was a very sad and tragic occasion.

"The final decision was made with less than six weeks left before the beginning of the school year and specifically targeted two districts," Wigent said. "There are many, many unanswered questions regarding this legislation." Wigent and the rest of the board decided to dissolve the district at the local level, instead of leaving it up to state superintendent of public instruction Mike Flanagan—the only two choices given Wayne RESA under this new law—and brings an end to an era.

It was also the responsibility of Wayne RESA to re-draw boundary lines and divide the students among four neighboring districts, and the division will fall as follows:

Students who live north of Michigan Avenue and west of

death of or imminent great bodily harm to himself or herself or to another individual.

(b) The individual honestly and reasonably believes that the use of deadly force is necessary to prevent the imminent sexual assault of himself or herself or of another individual. (2) An individual who has not or is not engaged in the commission of a crime at the time he or she uses force other than deadly force may use force other than deadly force against another individual anywhere he or she has the legal right to be with no duty to retreat if he or she honestly and reasonably believes that the use of that force is necessary to defend himself or herself or another individual from the imminent unlawful use of force by another individual.

Prior to this law, Michigan followed the common law doctrine that "a person had a duty to retreat before defending yourself". Now, you do not have to retreat before defending yourself, but there are certain constraints. You must:

1. Not be engaged in the commission of a crime. If you are a felon, and carrying a gun (which is a violation of Michigan law), then use that gun to defend yourself, this defense will not be available to you.

2. Must be in a place you are legally allowed to be. So if you trespassing, and use deadly force to defend yourself, this self-defense will not be available to you.

3. You must honestly and reasonably fear imminent death of, imminent great bodily harm to yourself or to another individual, and/or fear of imminent sexual assault of yourself or of another individual. This means you must actually believe that your life is in danger, great bodily harm is imminent, or fear of sexual assault. In addition, that belief must be objectionably reasonable. This means the jury will decide, upon hearing all the facts, what a reasonable person in your situation would have done.

In May 2012, after the death of Trayvon Martin, Democrats in the Michigan State House of Representatives announced a bill to repeal Michigan's "stand your ground" law, which currently protects citizens who use deadly force in self-defense. As the law stands, if a person believes he is at risk of being subjected to deadly force, great bodily harm or rape, he can use deadly force without first retreating.

Many states have some version of the law on the books. States That Have Stand Your Ground Laws are: Alabama, Arizona, Florida, Georgia, Indiana, Kentucky, Louisiana, Mississippi, Montana, Nevada, New Hampshire, Oklahoma, Pennsylvania, Tennessee, Texas and Utah.

Some states have self-defense laws, either through statute or case law, that are similar to stand your ground laws, but with at least one key difference. These laws generally apply only to the home or other real property (such as an office) and are often referred to as "castle doctrine" or "defense of habitation" laws.

These states include: Idaho, Illinois, Kansas, Michigan, Oregon, South Carolina, South Dakota, Washington, and West Virginia.

## NEWS FROM LANSING Senator Hopgood says Wayne RESA hands are tied

INKSTER - Senator Hoon-Yung Hopgood (D - Taylor) released the following statement in response to Wayne RESA School Board's vote this evening to formally dissolve Inkster Schools and disperse their students among the Romulus, Taylor, Wayne-Westland, and Westwood School Districts. The Romulus, Taylor and Wayne-Westland School Districts within are Hopgood's Senate District.

"Governor Snyder and the Republican Legislature have left the Wayne RESA School Board with their hands tied and in a no-win situation by dissolving the Inkster schools," said Senator

Hopgood. "Instead of attending the meeting, as he was invited to do, the Governor is nowhere in sight as he leaves the school board to clean up the mess he made, and answer to the parents and community who are understandably upset about this dissolution. The associated redistribution of students to surrounding schools is of grave concern to these schools and communities, which are already struggling."

Wayne RESA did not support the dissolution legislation passed by Legislative Republicans in June. Utilizing that statute, earlier this week, the State Superintendent and State Treasurer issued a joint declaration directing the dissolution of Inkster Public Schools. The statute called upon Wayne RESA to either reassign current Inkster students to other districts, or request State the Superintendent to make those decisions instead. Given only those two options under statute, Wayne RESA and the local school districts decided that the reassignment of students should be handled locally.

Middlebelt Road will attend Wayne-Westland Community Schools, which will also take control of the former Blanchette Middle School building on Henry Ruff; Students who live south of Michigan Avenue and west of Middlebelt Road will attend Romulus Community Schools, which will also take over the former Inkster High School building; Students who live north of Michigan Avenue and east of Middlebelt Road will attend Westwood Community Schools, and Students who live south of Michigan Avenue and east of Middlebelt Road will attend Taylor Schools, which will also take control of the former Inkster administrative offices, Meek-Milton and Baylor-Woodson, and the 9th Grade Academy buildings.

MHSAA will grant immediate eligibility to any student-athletes that were in the Inkster district in their new districts. Normally when transferring schools, the MHSAA requires that a student-athlete sit out at least one semester.

During an extended public participation period, former Inkster superintendent Mischa Bashir had a special message for her former students.

"You are bigger than any circumstance," she said through tears. "I expect you to represent the Inkster community well. Within you rests the hope for a better and brighter tomorrow."

Also during that participation period, many questions were raised, from the level of reception the students will receive, to communication and transportation issues, to even how the new districts will handle security in the buildings.

George Williams had questions about the law and RESA's handling of the situation.

"The only time a district can be dissolved is only on the recommendation of Intermediate School District. Why are we doing thing backwards?" Williams said.

He cited a section of MCL 380.12 Sec. 1 (b), which states that After consultation with the intermediate school district in which the district is located, the superintendent of public instruction and state treasurer jointly determine that all of the following apply..." before going on to list the six factors that qualify a district for dissolution. "The law stands. He said that he will uphold the law. He IS the law!" he said, in reference to Wigent.

Wigent answered that while he is familiar with the law, he said that his legal counsel had an interpretation of it that would not allow him to make a final, lasting decision as to whether the district would stay open or not.

"We have talked and agreed to disagree," Wigent said, referring to when he spoke to his legal counsel. "If there was a way around this, I would have used it."

In addition, he answered the question about consultation. "We received a letter asking for additional data and we responded that we did not have any to send them," he said. "That was the extent of our consultation."

Inkster mayor Hilliard Hampton, who was in attendance, questioned whether the district fell under a factor that said that they had failed to submit a viable deficit elimination plan.

""It's clear we did submit one and it was clear and made sense. We also had money to open the school district this upcoming year," he said.

"There are 1400 Inkster students in the district, so under the language we should have been prepared for this. I think this whole process was geared toward takeover and decimation of our community through social engineering by people outside of it."

While many mourned the passing of a school district, some citizens were ready to look to the future and what needed to be done.

"It's time to move on and do what we have to do. We have to go outside the box for the sake of our children," said Stephanie Bradshaw. "They will have to mix and mingle with everyone else out here. Lets get busy." Members of the RESA board were not happy either.

"To just come out of the woodwork and say we will dissolve a district is horrible," said RESA board member James Beri. "Inkster is just a start. They will continue to do this."

## Black Men most at risk for **Prostate Cancer**

Men, let's talk about prostate health.

Do you find yourself going to the bathroom more than once during the night regularly? Have you discovered that your urine flow has weakened or is intermittent? Have you noticed blood in your urine or semen?

If you answered "yes" to any of the above questions, it may be time to talk to your health care professional about prostate issues.

The prostate is a walnut-sized gland that sits under the bladder in front of the rectum. It surrounds the urethra, the narrow tube that carries urine and semen out of the body. The prostate gland grows a good bit during puberty and then doesn't change much

begins growing again and, in many men, doesn't stop. Half of men aren't bothered by their growing prostate. But the others will develop one of three prostate diseases; enlarged prostate, prostate cancer, or prostatitis. Other symptoms include painful or burning urination, difficulty with obtaining and keeping an erection, painful urination and ejaculation, and frequent pain or stiffness in the lower back, hips, or upper thighs.

#### **Risk factors**

Age: Jeff Cohen, MD, urologist at Allegheny General Hospital, says that age is the number one risk factor in prostate cancer. "If they live long enough, most men will be diagnosed with prostate cancer, because it's a normal degeneration of the prostate."

The incidence of prostate issues, including cancer, rises rapidly each decade after age 40. For example, the probability of being diagnosed with prostate cancer is 1 in 7,964 for men younger than 40 years, 1 in 37 for men aged 40 through 59 years, one in 15 for men aged 60 through 69 years, and 1 in 8 for men aged 70 years and older, with an overall lifetime risk of developing prostate cancer of 1 in 6. However, Cohen warns that autopsy studies reveal that the incidence of prostate cancer in males in there 20s is already 8 percent. Prostate cancer is the most common cancer diagnosed in men.

Race: Cohen is particularly interested in treating and advising African-American men with prostate problems because the death rate of cancer deaths prostate among Black males is alarming. Is race a factor? According to the Centers for Disease Control race is a factor, especially being African-American. Black males are more likely to die of prostate cancer than any other racial group, followed by White, Hispanic, American Indian/Alaska Native, and Asian/Pacific Islander men.

Heredity: Having a first





degree relative who had prostate issues also can put you at risk

Training camp is on as the Detroit Lions Football Team holds first training camp practice open to the general public this past Monday. What I saw compare to camps in the past is an atmosphere of competition that was extremely in high gear for all positions.

He takes a nice easy swing and has plenty of leg to hit anything on the field."

However, rookie cornerback Darius Slay is continually opening the eyes and impressing the coach staff on his workmanship since his arrival last Tuesday went the rookies check in to camp. Coach Schwartz was asked about the progress on Darius Slay: "He got some reps in OTA's in minicamp, but it was towards the ends. He has picked things up very quickly and he's matched up well against a lot of different types of receivers, from the smaller guys to the Calvin Johnson's. It seems like every day he breaks up a ball and gets his hands on a football. He's on the right path right now. We need to keep him there." Nevertheless, Schwartz said both Bartell and Green will undergo MRIs, and the Lions are already trying to combat the injuries in the secondary by shortening the field. The Lions needed to add depth along their defensive line and are turning to a familiar face to provide it.

The team signed defensive tackle Andre Fluellen to a oneyear deal last Friday, which will be his third stint with the club. Fluellen (6-2, 302) spent his first four seasons with the Lions after the team drafted him in the third round out of Florida State in 2008. Fluellen was released during final cuts last year due to a numbers game along the defensive line, but was re-signed in December. He played in the final three games of the season with one start. He had a brief stint with the Bears this off-season, but was released in

May.

Like Jason Jones and Isreal Idonije, Fluellen is a versatile player who can play both on the outside and inside at defensive tackle. Speaking of Jones, a key free agent, will likely be the starting left defensive end. In his absence, Willie Young and first-round pick Ezekiel Ansah played more with the first team, with Young moving to the left side. Yes indeed there is no place like home as the Detroit Tigers (59-45) outscored the Philadelphia Phillies 24-5 in a three-game sweep to improve to 6-2 against the NL East, however, both defeats came at Washington on May 8 and 9. The Tigers have won seven straight and 12 of 14 at home versus the NL East. The Tigers are rank first in Overall Runs (533), first in Overall Batting Average (.280), first in Overall Base Percentage (.346), and third in Overall Slugging Percentage (.437). The Detroit Tigers this past Monday announced the club has acquired right-handed pitcher Jose Veras from the Houston Astros in exchange for outfielder Danry Vasquez and a player to be named later on or before September 15, 2013. "We are pleased to add an experienced arm to our bullpen," said David Dombrowski, Tigers' President, CEO, and General Manager "Jose can pitch in a variety of roles, provides depth in the bullpen, and complements the roles of Joaquin Benoit and Drew Smyly." Veras, 32, has compiled a 0-4 2.93 ERA record,

(43.0IP/14ER) and 44 strikeouts in 42 relief outings with the Astros this season. Opponents are hitting .192 (29x151) against him this season, while he has issued 14 walks. He has posted a 0.00 ERA (8.0IP/0ER) and six strikeouts over his seven outings during the month of July. Originally signed by Tampa Bay as a non-drafted free agent on January 19, 1998, Veras has seen action at the major league level with the Yankees (2006-09), Indians (2009), Marlins (2010), Pirates (2011), Brewers (2012) and Astros (2013). In parts of eight seasons at the major league level (2006-13), Veras has compiled a 19-21 record, 3.88 ERA (357.1IP/154ER) and 372 strikeouts. The 6-6, 242 lbs. right-hander is a native of Santo Domingo in the Dominican Republic. Vasquez hit .281 (105x374) with 16 doubles, five triples, five home runs and 39 RBI in 96 games with Single A West Michigan. The Tigers will finish their home stand against the Chicago White Sox. ## WCSO, ATF & WSU Police conduct raids targeting drug trafficking in **Senior Housing**

Individuals accused of taking over apartments to sell drugs, weapons.



Detroit (July 29, 2013) - A multi-jurisdictional effort to protect senior citizens and reduce crime shut down several narcotics operations conducted at two senior housing complexes in Detroit. The "Save Our Seniors" investigation led to today's execution of 87 warrants against 46 individuals. So far, 32 subjects are in custody. The defendants are accused of committing felony assaults and selling narcotics (cocaine, heroin and marijuana) and firearms at Orchestra Towers (3501 Woodward) and Cityview Towers (4701 Chrysler Service Drive).

Today's early morning raids by the Wayne County Sheriff's Office (WCSO), Bureau of Alcohol, Tobacco, Firearms and Explosives (BATF) and Wayne State University Police Department (WSUPD) were simultaneously conducted starting at 7 a.m. Law enforcement officials say the suspects would intimidate and

overtake seniors' apartments to distribute narcotics.

"They're pushing dope in these buildings, terrorizing our most vulnerable citizens. and that won't be tolerated." said Sheriff Napoleon. "With our partners at the ATF and WSU, we've been able to make this building safer and, hopefully, these seniors will rest a lot easier tonight." Napoleon activated the WC Special Response Team to help execute the warrants which drew applause from those watching.

"We determined that several suspects were actually residents which meant we needed to make solid cases to ensure they don't return to continue their drug activities," said WSU Police Chief Anthony Holt. "We're doing what we can to create safe living environments for the seniors surrounding our campus."

Operation SOS was initiated

#### following several tips to the **Detroit Housing Commission** in November. Of the 46 arrest warrants issued, eight are federal defendants. The remaining thirty-eight defendants are facing state charges. Only one suspect was female and another defendant was wheelchair bound. All were arrested on charges of trafficking narcotics. Those arrested were transported to Jail Division 3 for processing and should be arraigned in the next few days. Many of the individuals arrested could be facing lengthy prison terms.

"The first priority of ATF is to make our communities safer from violent criminals, narcotics trafficking and firearm violence. These threats to communities are even more reprehensible when senior citizens and students are the targets, said ATF Acting Special Agent in Charge Daryl McCrary. "I commend the dedication and hard work of the ATF Agents, Wayne State University Public Safety Department and the Wayne County Sheriff's Office."

Mugshots of the numerous individuals arrested in today's operation will be forwarded once they have been processed. More arrests are expected in this case as the remaining suspects are located. The office of the U.S. Attorney, Detroit Firearms Investigative Team and Wayne County Prosecutor's office also assisted in today's action. For more information please email pbridges@waynecounty.com.
