The citizens of Ecorse have turned up the heat on air conditioning thieves. They along with the Ecorse police department are letting the thieves know that they will not stand by and be victims anymore.

The latest incident was foiled in the wee hours of the morning on September 28. Officers Olson and Cieszkowski responded to the area of 15th and Salliotte where several black males were standing around the townhouses in the area.

Due to the recent larcenies in that area, the residents called in the suspicious group when they observed one of the subjects carrying a pair of 'Boltcutters'.

LANSING, Mich. - Michigan residents have until Monday, Oct. 7, to register in order to vote in the Nov. 5 election, said Secretary of State Ruth Johnson.

"I would encourage all qualified residents to register to vote," said Johnson, Michigan's chief election officer. "Registration takes only a few minutes and will enable voters to be a part of democracy and have their say on Election Day."

Elections are being held in 75 of Michigan's 83 counties on Nov. 5. The polls will be open Westland, MI -City dignitaries, department heads and members of the Westland City Council are inviting residents, the press and business leaders to join them in a Groundbreaking Ceremony to inaugurate the transformation of Westland's new City Hall building. With shovels and sledgehammers in hand, they will gather at the former City Circuit building on Warren Road on Monday, October 7 at 11am to kick off a momentous occasion in the City's his-

#### tory.

Upon completion, City offices will move from the Ford Road City Hall, built in 1966, to the newly retrofitted 64,000

### Blackonomics Knowing Better, but not Doing Better

As the saying goes, "Once you know better, you should do better." Most of us can remember situations that would have benefitted us in some way or another had we only used the knowledge we received from our parents, our elders, our friends, or our teachers. Many accidents could have been prevented, many tragedies could have been averted, a lot of heartache could have been avoided, and a great deal of jail time would have been skipped. Think about it. We have knowledge but fail to act appropriately with the knowledge we have and, therefore, end up paying dearly for not doing better even though we know better.

Collectively, Black people continue to practice inappropriate behavior despite having a wealth of knowledge, or at least have access to it. We have folks who share knowledge with us on a daily basis, but we fail to put it to good use. We are intellectually lazy, and we refuse to move once we obtain knowledge that will assist us in our quest to get off the bottom rungs of this society.

Admittedly, many of us only have information, and we have it coming out of our ears. Just listen to some talk radio shows. or listen to the brothers in the barber shop. We are experts in everything. No subject is foreign to us. You name it, we can discuss it and make others believe we know what we're talking about. That's the difference between having knowledge and just having information. Knowledge, understanding, and wisdom (which is the proper application of it all), are what we should seek.

Our leaders are telling us everything is getting better, or it will get better, if we would only "keep marching" – as if that will change our condition. While we are marching other folks are taking care of their businesses, selling us marching shoes, caps, and T-shirts that, show the world how angry we are.

We have a Congress that keeps threatening to shut down the government, thus, stopping services and in some cases, curtailing or delaying pay and benefits for "the people," knowing all the while that their pay and benefits will keep right on coming if that happens. What a heartless group of guys and gals they are; we know better. but we elect them to rule over us. They make rules that only we have to follow, rules that will devastate "the people" but exempt them and their families - and we put them in office. We know better, but we don't do better.

When Warren Buffett himself comes out and says, "Inequality is getting worse," and adds that since our near economic disaster five vears ago, business has come back and now the rich are faring very well. We had better listen to that knowledge. He notes the aggregate wealth of the Forbes 400 is as much as \$2 trillion. But he also says that the general populace is suffering. The bottom 20 percent of households (24 million households, 60 million people), at the top level, earns just \$22,000. Our economy is delivering \$50,000 in GDP per capita and we have an awful lot of people not living very well. "I don't want to try to live on \$22,000 with a couple of kids," Buffett continued.

So what about you? We know Warren is living larger than any of us can imagine, but he is still correct in his assessment. His wealth does not automatically negate his knowledge of the financial markets and the economic conditions of our society. We have the same general economic knowledge he has; or we have access to it. We can see what he has done with his knowledge; what have we done

# NEWS FROM LANSING House Committee Approves Scrap Metal Theft Bills

Bills increases tools for prosecutors to hold illegal scrappers accountable

LANSING –The state House Committee on Regulatory Reform voted out two scrap metal bills today co-sponsored by state Representative Rashida H. Tlaib (D-Detroit). House Bills 4593 and 4595 tighten regulations by including all types of scrap metals, requirements for scrap metal, dealers and sellers to follow, and penalties for anyone who buy or sells stolen scrap metal.

"As a recent victim of scrap metal theft myself, I am proud to report that the state House Committee on Regulatory Reform today voted out two scrap metal bill, House Bills 4593 and 4595, which I have championed for over 3 years," said Tlaib. "These bills tighten regulations by including all types of scrap metals, not just nonferrous, it gets rid of the instant cash attraction by delaying payment for catalytic converter, air conditioners and copper wire as well as requiring a photo of the metals being purchased, training of all scrap yard employees and identifying the employee that weighs and inspects the material on the scale."

House Bill 4593 also includes an expanded list of items that dealers cannot buy unless the seller has proper authorization. "In an effort to strengthen the tools of law enforcement to stop scrap metal theft, this package provides the hammer and nails to discourage those who are breaking the rules," said Senator Jim Ananich (D-Flint), who sponsored HB 4595 when he served in the House. "Today's vote was an important step forward in protecting our homes, businesses, and places of worship from being torn apart."

Scrap metal theft doesn't just happen in urban areas. It is also a problem in Michigan's rural communities.

"Scrap metal theft is a statewide issue, impacting not only Michigan's urban areas, but also its rural communities," said Rep. Paul Muxlow (R-Brown City), sponsor of HB 4593. "As metal theft has risen in this state, rural communities like those in the 83rd district have experienced а dramatic increase in metal theft to farm equipment, and even wind turbines. To help stop this epidemic, we have done our due diligence and put together bipartisan reforms which will discourage bad actors and provide more tools for law enforcement to prosecute thieves."

gathered, I would say this Magnificent Man is sort of like Jeffrey Fieger of the Tennessee. He is Kevin C. Kennedy, a prominent attorney in civil and criminal practice, both on the state and federal level in Montgomery County in TN.

He graduated with honors from Austin Peay State U and now owns the Kennedy Law Firm. He has been a Professor of law at colleges and has served as Dean of Legal Studies at Draugns Junior College as well as Bowling Green in Kentucky.

After the Persian Gulf War, also known as Operation Desert Storm, Kennedy was invited to appear on the Oprah Winfrey Show where he shared his knowledge on wartime divorces. During this same time, he was interviewed by the Washington Post, New York Times and CNN to share his expertise.

Kennedy designed and uses a replica of a courtroom in the rear of his office to teach by using a full-scale simulated court, complete with bench, bar, jury panel, counsel tables, judge's chamber, jury deliberation room, inmate holding room and spectator seating to teach students how the court system works. Local schools use the facility for training with mock trials. It is called: The Court of Creativity and it housed Montgomery County's first Teen Court.

Kennedy owns the Kennedy Walking Horse Farm which has been in his family for over 109 years. He is published author of the book How to Make Money in the Tennessee Walking Horse Business, which sold nationwide.

Kennedy was named the 2004 volunteer of the year by the Ed Atkins Foundation for Clarksvillians, named William Beach Montgomery Ο. County Citizen of the Year and City of Clarksville Citizen of the Year both in 2008, serves on the Austin Peay State University Foundation. is a member of the Governor's Club, and is a member of First Baptist Church of Clarksville where he teaches Sunday School and is a Deacon.





#### LANSING, Mich. - October is Breast Cancer Awareness Month in Michigan and all official state of Michigan social media accounts will be "going pink" for the second year in a row, Gov. Rick Snyder

"A woman in the United States has a one in eight chance of developing invasive breast cancer in her lifetime. But when breast cancer is caught early and treated, survival rates can be near 100 percent," said Snyder, whose wife, first lady Sue Snyder, successfully battled breast cancer. "During this month we join with numerous organizations, agencies and health professionals to raise breast cancer awareness in Michigan, and to remind women everywhere that regular screening and early detection are crucial to surviving this invasive disease."

The "M" in the Pure Michigan logo, usually seen in blue or green, will be made pink in social media profile images and platform backgrounds for the entire month of October. State of Michigan department Web pages, the official Michigan.gov portal and Snyder's website will also display the pink "M" for the cause. The state of Michigan launched the effort last year and received overwhelming support from state agencies, partners and residents across Michigan.

This year, Michigan residents are encouraged to tweet, post and share their story and images using the #puremipink hashtag on Twitter, Facebook and Instagram. Appropriate images will be shared and cataloged in a special gallery on www.michigan.gov/socialmedia. A list of breast cancer awareness events around Michigan will be available on the Pure Michigan blog: http://www.michigan.org/blog/ link-roundup/pure-michiganpink-recognizes-breast-cancer-awareness-month.

Breast cancer is the second leading cause of cancer deaths among Michigan women and the most commonly diagnosed cancer, with an estimated 8,140 women to be diagnosed in 2013, according to the American Cancer Society.

The Michigan Cancer Consortium, Michigan Department of Community Health, American Cancer Society and the American Medical Association recommend that women age 20 and older have a clinical breast exam performed by a health care provider every three years. Women age 40 and older should have a screening mammogram and clinical breast exam every year and should continue to do so for as long as they are in good health.

Women who cannot afford a mammogram may qualify for free breast cancer screening and diagnostic services through the Breast and Cervical Cancer Control Program (BCCCP). To be eligible for the program, women must meet the following criteria:


•Have an income below 250 percent of the federal poverty level (for example, in 2012 a family of two can earn up to \$38,775 per year and still qualify).

•Be uninsured or underinsured.

•Be between the ages of 40 and 64.

Three years after becoming law, plenty of Americans really don't understand what the Affordable Care Act – also known as Obamacare – already does, and what it will do in the near future. It's time to know what the health care law can do for you and your family.

In this tough economic climate, African Americans all over the country are struggling to find employment, much less jobs with health benefits. According the U.S. Bureau of Labor Statistics' July report. 12.6 percent of black Americans were unemployed. Even among those who are employed, health insurance coverage can be elusive. While the majority of people of color - including African Americans – have a full-time worker in the family, they are more likely to be in low-income, low-wage jobs that provide limited access to employer-sponsored health insurance.

In addition, there are also benefits for older Americans receiving Medicare under the health care law. Annual wellness checks are available at no cost. Diet counseling and smoking cessation classes are also provided at no costs for those who qualify.

Plus, there's another big benefit: insurance companies can't deny coverage to people with pre-existing health conditions, nor can people be dropped from an insurance plan because of their health conditions. These are significant changes brought about by the health care law.

Regardless of how people feel about the law, it is the law. And knowing its benefits can make a difference in your life. To help, AARP has created a new online tool called www.HealthLawAnswers.org — a quick and easy way to get customized information based on where you live, gender, your family size, income, and insurance status.

It's everyone's right and everyone's business to know how the health care law affects their lives and their health. Get informed. It's time.



### **Thee Lions Beat the Bears**

It has never been as loud as it was this past Sunday at Ford Field. With the crowd playing the roll of the 12th man for the Lions was the energy needed for a 40-32 win vs. the Chicago Bears.

The Lions improved their record to 3-1 on the season and marks the second time in the past three seasons the team has jumped out and won at least three out of their first four games (4-0 in 2011). It also marks the second time under Head Coach Jim Schwartz that he has led the team to 3+ wins in the Lions' first three games. With a win over Chicago this past Sunday, Detroit also improved its NFC North record to 2-0 on the year.

With the game tied 3-3 heading into the second quarter then the explosive for the home team were set off as the Lions went in to halftime with a 30-13 lead over the Bears, as they exploded for 27 points in the second quarter. The 27 points by the Lions set a franchise record for the most points ever scored in the second quarter of a game. The previous best was 24 points accomplished three other times. Detroit is now +4 in turnover margin this season (11 takeaways, 7 giveaways). The Lions' four takeaways vs. Chicago led to 17 points off takeaways.

With a fumble return touchdown, the Lions have now scored two defensive touchdowns this season after recording zero in 2012. Three picks Sunday, it marks the most interceptions gathered by the Lions defense vs. Chicago since they had four October 28, 2007. In this past Sunday win, QB Matthew Stafford completed 23 passes and became the first

Running back Reggie Bush rushed for 139 yards on 18 attempts (7.7 avg.) and scored on a 37-yard touchdown in the Lions' win today. It was Bush's first 100-yard rushing game since joining the Lions and the eighth of his career. His 139 yards were the most by a Lions running back since RB Kevin Smith recorded 140 rushing yards vs. Carolina November 20, 2011. With the Lions trailing 10-9 in the second quarter, Wide receiver Michael Spurlock ignited the Lions' scoring as he set the Lions up for their first touchdown drive of the game with a 57-yard punt return. The punt return gave the Lions the ball at the Chicago 22-yard line. Defensive tackle Ndamukong Suh recorded two sacks (22 yards loss), four tackles, two tackles for loss and a sack-fumble in the Lions' 40-32 win vs. Chicago. With two sacks today, it marked Suh's third career multi-sack day and the second time in his career he has registered 2+ sacks in a game. Suh's multi-sack day was his first since he had 2.0 sacks vs. Washington October 31, 2010. His second sack of the day was also a sack-fumble that turned into a 4-yard fumble return for a touchdown by Defensive tackle Nick Fairley. Safety Louis Delmas intercepted the Bears twice in today's win vs. Chicago, marking the first time in his career that he picked off two passes in the same game. Safety Glover Quin notched his second interception of the season when he picked off a Bears pass in the second quarter and returned it 42 yards as he was tackled at the Chicago 2-yard line. On the next play, the Lions scored on a 2-yard touchdown pass from Stafford to Johnson that gave the Lions a 23-10 lead. Quin now has two interceptions with the Lions and seven in his career. Lions Head Coach Jim Schwartz after the game commented on the importance of turnovers: "We have been good at turnovers. They made their plays also. They had a couple of turnovers that led to points. Our guys make their plays. We can't worry about what other people say about us or what they say about our opponents. We know what we have. We need to go out and play hard, play tough, play physical. We need to make our plays. Our guys have proven this year that they can do that. It was a big problem for us last year. We didn't get very many turnovers on defense. We got some playmakers on defense. We have some guys up front that can rush and guys in the back end that can go get the ball. We had a lot of injuries in the back end today, but we were still able to make enough plays to win the game." The Lions will travel to Green Bay this Sunday to take on a tough Packers team.

# The Wyandotte Bears Beat Melvindale Cards in a Close One

## Rouge takes down Consortium, 28-6

River Rouge's mascot might be the Panthers, but a new nickname for them may be the Panther Express.

The Express...I mean, Panthers...showed off their ground game last week, scoring all but one of their touchdowns on the ground in a 68-8 thrashing of Detroit Community.

And despite a few bumps in the road during the game, they continued trucking along, rolling over Detroit Consortium on Saturday, 28-6, at Detroit Northwestern's football field. It was not a perfect game by any means, hence the bumps in the road. Both teams combined for seven turnovers (three interceptions, four fumbles).

"It was a sloppy game on both parts," said Consortium assistant coach Tim Hopkins. "We had a lot of turnovers and a lot of penalties. Whenever we seemed to get some momentum, we'd shoot ourselves in the foot by turning it over."

River Rouge head coach Corey Parker agreed somewhat. "I'm glad we won, but we didn't take care of the ball well tonight," he said. "We have to have better ball security."

The Cougars drove to the Panthers' red zone twice in the first half and were denied both times by turnovers. Rouge's Havert Beal stripped the ball on the first Cougar drive, and Keiland Reeder intercepted the ball in the end zone to end the second

Rouge got on the board in the first quarter, when Justin Patterson-Turner ripped off a 38-yard touchdown run. Jujuan Kemp punched in the extend the Panthers' lead to 16-0.

Rouge's Dontez Blackshear picked off a Cougar pass on the ensuing drive, and his 48yard run set up a 1-yard quarterback sneak from Dontes Sims to give River Rouge a 22-0 halftime lead. Consortium finally answered in the fourth quarter, when Lavelle Griffin snagged a tipped pass out of the air in the end zone from Tre-Von Williams.

But the Panther Express was not done yet, as Kemp finished the scoring with a 14yard touchdown run. The Panthers (3-1, 2-0 MMAC) won the game without registering a single passing yard, racking up nearly 300 yards and all of their scores on the ground. But it was not for lack of trying. Kemp led the way with 122 yards rushing and three touchdowns. Patterson-Turner added 80 yards, and Blackshear chipped in his 48yard run.

The Cougars drove to the Panther red-zone once more, but River Rouge's Knico Hartford pulled off a sackfumble recovery on fourth down to clinch the victory—a testament to how strong the Rouge defense had been throughout the whole game, and all year.

"That's what we try to do," Parker said. "If you can't run the ball in Michigan, and you can't stop people, you won't be playing for very long. Our passing game is effective, and we did try to pass it today and it wouldn't work. But we hang our hat on running the ball and stopping people."

Defensively, Beal led the charge with eight total tackles, a forced and recovered fumble and a sack. Reeder chipped in six total tackles to go along with his interception, and Blackshear added five tackles with his pick. Dequan Butler also added an interception for River Rouge.

### Trojans squeak by Romulus Eagles, 12-6, in defensive battle

If you like a high scoring football game, then Friday's game between Romulus and Livonia Clarenceville was not for you.

But if you are a defensive enthusiast, then Romulus Middle School's football field was the place for you. Both teams accounted for only two touchdowns (only one offensive) in Clarenceville's 12-6 victory over the Eagles.

Clarenceville (5-0, 3-0 WWAC-Red) answered by marching down the field and capping their drive with a twoyard run by James Hill. The made extra-point gave the Trojans a 7-6 lead.

The Trojans threatened at the end of the second quarter, but a tremendous defensive stand by the Eagles turned them away. The two teams continued to trade hard hits until Clarenceville's David Vandekerckhove kicked a field goal late in the second quarter to spot the Trojans a 10-6 halftime lead.

Romulus's punt return man, Mike Hall, also provided a great deal of entertainment on the night with his efforts to get good position for the Eagles. After a Romulus penalty backed the Eagles up to the 1-yard line, Clarenceville's Drake Taylor tackled the Romulus back in the endzone for a safety to open up the fourth quarter with a 12-6 lead.

Clarenceville (4-0) seemed to have new life after a winding punt return got the Trojans excellent field position at the Romulus 43, but Romulus made another defensive

on Election Day from 7 a.m. to 8 p.m. To find out if there is an election in your community, confirm if you are registered or to see a sample ballot, visit www.michigan.gov/vote.

To register to vote, applicants must be at least 18 years old by Election Day and be U.S. citizens. Those individuals must also be residents of Michigan and of the city or township in which they wish to register to vote.

Voters may register by mail or in person at their county, city or township clerk's office or by visiting any Secretary of State office. When registering in person, voters must present identification or sign an affidavit stating they do not have identification with them. The mail-in form available is at www.michigan.gov/elections. First-time voters who register by mail must vote in person in their first election, unless they handdeliver the application to their local clerk or are at least 60 years old, disabled or are eligible to vote under the Uniformed and Overseas Citizens Absentee Voting Act.

smartphone version of the website is also available.

Voters who qualify may choose to cast an absentee ballot. As a registered voter, you may obtain an absentee ballot if you are:

#### \*age 60 or older.

\*physically unable to attend the polls without the assistance of another.

\* expecting to be absent from the community in which you are registered for the entire time the polls will be open on Election Day.

\* in jail awaiting arraignment or trial.

\*unable to attend the polls due to religious reasons.

\*appointed to work as an election inspector in a precinct outside of your precinct of residence. The revised application forms also remind voters that they must be citizens in order to vote.

Michigan law requires voters to provide identification when at the polls on Election Day or when obtaining an absentee ballot in person at a clerk's office. They will be asked to present valid photo ID, such as a Michigan driver's license or identification card. Anyone who does not have an acceptable form of photo ID or failed to bring it with them can still vote. They will be required to sign a brief affidavit stating that they're not in possession of photo ID. Their ballot will be included with all others and counted on Election Day.

Voters who don't have a Michigan driver's license or

By signing the application, the voter attests that he or she is a U.S. citizen. identification card can show the following forms of photo ID, as long as the identification is current:

\*Driver's license or personal identification card issued by another state.

\*Federal or state governmentissued photo identification. \*U.S. passport.

\*Military identification card with photo.

\*Student identification with photo from a high school or an accredited institution of higher education, such as a college or university.

\*Tribal identification card with photo.

This was the last house our students purchased in the 2011 auction. The property was identified by a member of our staff who was participating in the Wayne County auction for the first time. It was a great looking house located on a great block in tough area and we snagged it for \$500 dollars. Early indications suggested that this deal was going to be a loss as the tenants missed several appointments and wouldn't answer our phone calls.

We placed the property on the back burner and after months of non-payment we moved forward with eviction proceedings (which cost use about \$200 dollars). Once we received a judgment in our favor the tenant was chasing us down asking for a meeting. We ended up negotiating a lease option for 28 payments of \$350/month for a total of \$9800 dollars. Once 28 on time payments have been made we'll sell them the property for \$1 dollar. They haven't missed a payment since. Does this sound like an investment you'd be interested in? 
him with a closed hand fist, while kicking him. The male states they took his cell phone and bicycle when they stopped assaulting him. Then they took off running

Stewardess Frantically Searches for Mr. Right in Peripatetic Romantic Comedy Film Review by Kam Williams



Montana Moore (Paula Patton) is in quite a quandary. The pretty stewardess is practically 30 years-old, the age by which her meddling mother (Jenifer Lewis) insists any young lady must marry to be considered respectable.

Meanwhile, her younger sister, Sheree (Lauren London), who's just a sophomore in college, is already engaged to a big man on a campus (Terrence Jenkins), a Heisman trophy hopeful with a bright future in professional football. The blissfully betrothed are set to tie the knot in a month, and Montana is determined to turn one of her former boyfriends into a fiancé prior to their wedding day.

So, enlisting the assistance of a couple of colleagues, Gail (Jill Scott) and Sam (Adam Brody), she proceeds to hack into her airline company's reservation schedule to determine the travel plans of her ex-beaus. Montana's unsuspecting candidates include a producer (Trey hip-hop Songz), a Republican politician (Taye Diggs) and a filthyrich businessman (Djimon Hounsou), but not the lifelong friend (Derek Luke) living right across the hall who had once proposed to her when they were in grade school.

Consequently, the desperate spinster starts crisscrossing

the country to orchestrate "chance" encounters with wellheeled old flames while her Mr. Right might very well be the next-door neighbor she keeps leaving behind in Baltimore. And although the audience is never in doubt about the eventual resolution, it takes Montana most of the movie, of course, to wise up and realize that she's meant to marry the working-class hero who has long admired her from afar.

Written and directed by David E. Talbert, Baggage Claim is a fairly-transparent soap opera which tends to telegraph its every punch. Thanks to the intermittent comic relief coming courtesy of the irreverent Greek chorus comprised of flamboyantly gay Sam and boy crazy Gail, this exercise in the obvious is nevertheless a lot of fun to watch. It also helps immeasurably that the protagonist and her hunky suitors are so easy on the eyes.

A pleasant, if predictable, romantic comedy trading in the same sort of moralizing and colorful characters of a typical Tyler Perry production. The only thing missing is a sassy, self-righteous, pistolpacking granny in a dress.

unprecedented and will have serious consequences for the entire Nation," said Conyers.

"The Republican government shutdown will also have a devastating impact on federal Judiciary and law enforcement agencies. Specifically, over the last day I have learned that, amongst other things, a government shutdown will lead to the following:

Ø In two weeks time the federal Judicial system will close down for all cases except those deemed most essential Ø Attorneys at the Justice Department may be prevented from protecting public health and safety, and to recoup billions from fraud and abuse of federal funds

Ø FBI agents will be unable to receive critical training for recruits at Quantico, in addition to the FBI being unable to bring in new agents next year because of budgetary cuts

Ø Over 404,000 enrolled employers and U.S. businesses will be hurt from being unable to have needed access to E-Verify, the Internet-based system that allows employers to voluntarily determine the eligibility of prospective employees to work in the United States. Last year more than 21 million queries were sent through the E-Verify system

Ø The Office of Foreign


Labor Certification at the Department of Labor will close and neither accept nor process any Labor Condition Applications, Applications for Prevailing Wage Determination, Applications for Temporary Employment Certification, Applications for or Permanent Employment Certification. This effectively prevents employers from seeking green cards for their essential employees, as well as from applying for high-skilled H-1B visas, agricultural H-2A visas, or non-agricultural H-2B visas.

Ø A government shutdown would result in the closure of most U.S. immigration courts, further adding to the backlog of immigration court dockets, which already suffer from yearslong delays.

"These dire effects of a government shutdown come in addition to the

\$85.4 billion in budgetary sequester cuts already in place for 2013. The federal Judiciary alone has already taken a \$350 million budgetary hit, with a \$52 million shortfall for federal public defenders providing legal representation to indigent offenders. In addition, funding has been severely curtailed for substance abuse and mental health treatment, as well as for probation and pretrial services officers.

"Holding the federal government hostage over ideological demands is a reckless way to govern, and I urge my Republican colleagues to abandon this divisive approach. Playing politics with the fiscal health of the United States, and the actual health of the American people over the Affordable Care Act, is irresponsible and must come to an end."
