# Review team appointed to examine Lincoln Park finances

Next step following PA 436 preliminary review



Gov. Rick Snyder today appointed a financial review team to examine the finances of the City of Lincoln Park, under Public Act 436 of 2012 (Local Fiscal Stability and Choice Act). The appointment of a review team is the second step in the PA 436 process, if the Local Emergency Financial Assistance Loan Board (ELB) determines "probable financial stress" exists in a local unit of government following a

preliminary review by the Department of Treasury. The ELB reached that conclusion for Lincoln Park last month.

The Department of Treasury's preliminary review of the City of Lincoln Park's finances found numerous conditions, including:

• During fiscal year 2013, the city's General Fund (GF) bor-

# Belle Isle becomes newest state park Recreation Pass will be phased in



On Monday, it became official. The state will run the city-owned park under a 30-year lease deal with Detroit emergency manager Kevyn Orr. The Department of Natural Resources is taking over management of the 985-acre island park in a move that's expected to save the bankrupt city between \$4 million and \$6 million a year.

The DNR said current park rules and hours remain in effect for the Detroit River island, which is Michigan's 102nd state park.

"The DNR has worked to ensure a smooth transition for Belle Isle with the goal of enhancing this world-class place for the residents of Detroit and Michigan," DNR DirectorKeith Creagh said in a statement. "We are excited ... to help revitalize this important community gathering place."

The state said it plans to make improvements and is working with the city, the Belle Isle Conservancy, the Belle Isle Park Advisory Committee and others. The Michigan Department of Transportation is taking over responsibility for park roads and bridges.

There will be a new \$11-percar annual fee to visit, paid as part of a state Recreation Passport, that will be phased in gradually.

A Recreation Passport is needed to enter Michigan's state parks, recreation areas and forest campgrounds. Drivers heading to Belle Isle won't have to get one during the first year of state management until their next license plate registration renewal. If the renewal date is in November, for example, it's required then.

Pedestrians, bicyclists and those using public transportation may enter the park for free, and the DNR said it is working with the city to reestablish a public bus route to the island. Park rangers will greet visitors just north of the McArthur Bridge, which connects to the island.

"These partnerships are essential to success at Belle Isle Park," said Ron Olson, chief of the DNR Parks and Recreation Division.

In addition to Belle Isle, the Recreation Passport gets the holder's vehicle into all state forest campgrounds, boat launches, trailhead parking, and Michigan state parks and recreation areas, including many -Bald Mountain Recreation Area, Dodge 4 State Park, Highland Recreation Area, Island Lake Recreation Area, Maybury State Park, Milliken State Park, Proud Lake Recreation Area and Sterling State Park. 

# Relationship Wreckers: 10 Faults Lethal to Your Love Life



Relationships often collapse because couples are not prepared to withstand the inevitable conflicts or even the humdrum and monotonous plateau period that's nearly certain to present as the years go by. A relationship can feel more like "boot camp" when trying to acclimate to each other's personality differences and habits-frustrations, tensions, and resentments that can persist well into a longterm love affair and undermine the ability to feel happy and content. For other couples, it's shear boredom that can wreak havoc-if the partnership doesn't continue to stimulate and enrich their lives, the doldrums can be a relationship death knell!

"When couples do not understand these are anticipated and natural events in the course of a relationship, they may start looking for the exit door thinking that they have made a grievous mistake," notes Dr. Jacqueline Del Rosario, "America's Marriage Coach." "But, many people don't realize the extent to which their relational health and happiness is under their own control. That power lies in one's ability to self-assess and foster quality communication with their partner."

Below Dr. Del Rosario has identified 10 relationship wreckers. Turning these faults around can not only help a relationship survive, but also thrive so that both partners can actualize their dreams of "happily ever after":

- 1. Not putting your best face forward. People dress up in their best clothes, make sure their hair is done, and put on makeup for the outside world. Do you put forth the same effort to impress and excite your mate?
- 2. Not continuing to grow. You must come to a relationship, willing to continuously improve who you are so that your relationship can continue to evolve. Consider trying new things together. Exploration and adventure can go a long way to keeping things fresh and appealing and will help you understand and appreciate who your partner is today. Continue to date and experience new things as a couple.
- 3. Not continuing to invest the time and effort to maintain a strong foundation. All good things take work, and both parties must roll up their sleeves and commit to doing their part to add value to the union. This includes continually stoking the flames of passion. Are you as proactive or even adventure-some in the bedroom, or are you relegated to business as usual? Break the routine here and watch the magic ensue.

- 4. Not knowing the relationship 'anchors.' What are the things that keep you rooted and well-connected with your partner? Why are you together in the first place? Identifying and nurturing similar values, goals, and expectancies in your relationship are fundamental and will help you endure during the tough times.
- 5. Not ensuring an effective communication style. It is essential to learn how each party in the partnership prefers to communicate. You must then make the conscious effort to deliver and receive messages from your mate according to their personal style, which may differ from yours. Knowing when and how to disseminate information is a key relationship skill that can be a saving grace unto itself. And, during an argument, always fight fair and with respect—no name calling, no degrading one another, and no using your tongue as a weapon of mass destruction.
- 6. Not addressing unmet expectations. Unfortunately, unmet expectations are often not shared and, instead, they can fester within and result in resentment and bitterness. How can you expect your mate to meet your expectations if you don't voice them? It's unfair of you to feel that your partner "should know" or be able to decipher passive aggressive cues that something is wrong. Met expectations equal relational bliss, so be honest with what you need from your partner for a real chance that those needs will be met, or even exceeded.
- 7. Not resolving emotional triggers that might be adversely affecting the relationship. Triggers link back to past traumas and can hinder the way we respond to or even perceive present day issues. Were you lied to or cheated on in the past? It doesn't mean you cannot trust your current mate. Did your past partner drink too much? It doesn't mean this partner can't enjoy a cocktail responsibly. Put your old baggage aside and experience your current partner on their own merits and actions.
- 8. Failing to stop, look, and listen. Take the time to listen to and validate your mate. Couples often decrease their talk time once they have been together awhile and feel comfortable. Keep the channels of communication open-chatter about the day's events, current events, family matters and similar. It bonds the heart and abates the feeling of growing apart. Should a concern be expressed along the way, it's imperative to hear your mate and try to empathize with how they feel.
- 9. Allowing outside interference. There is a reason "interference" is a penalty in most sports. It is because someone is getting involved where and when they do not have a right. This can result in focusing on the wrong issues and reinforcing dangerous and emotional conclusions that can be detrimental to your relationship. Your partner may

also be very angry to find out that others are now involved in your private life. Instead, go directly to your partner to resolve relationship problems. However, if things are critical and seemingly out of both of your control, qualified assistance can come from marriage coaches and counselors who are there to help get the dialogue between the two of you on the right track.

10. Not having a relationship maintenance plan. Are you still doing what you did to get your mate? Do you know exactly why your mate should or would want to stay with you in the months and years ahead? What emotional benefits do you offer your mate that others don't? Take the time to assess what your virtues are and even ask your mate to cite favorite qualities about you. Then, make a concerted effort to foster these qualities to not only ensure interest remains, but also maximize the caliber of that interest



rowed \$2.5 million from the Water and Sewer Fund to make its annual pension payment. The city has stopped making required debt service payments to SunTrust Bank. Due to nonpayment of the loan, SunTrust has filed a federal lawsuit against the city;

- The city has violated requirements of the Uniform Budgeting and Accounting Act. For fiscal year 2012, there were several activities in the GF that went over budget with General Government being the largest at \$501,892. All GF activities that went over budget totaled more than \$711,302;
- The city has experienced a decline in revenues for several years. The city's taxable value has declined 31.5% over the past four years (\$793,184,868 in 2009 compared to \$543,044,201 in 2013). As a result, the city's GF revenue has declined from \$24.6 million as of June 30, 2009 to \$20.3 million as of June 30, 2013. Property tax revenue accounts for 60% of the city's GF revenue;
- In 2003, the city's pension the Municipal plans, Employees' Pension Plan and Police and the Fire Retirement System, were 70.1% and 101.3% funded respectively. The actuarial valuation as of June 30, 2013 (Municipal Employees') and December 31, 2013 (Police and Fire), indicates the city has a \$69.1 million unfunded pension liability and a funding status of 28.0% and 34.6% respectively.

# Don't Fall for Valentine's Day Scams

On Valentine's Day, people's emotions run all over the map some are head-over-heels and want to shower their loved one with gifts, while others are despondent because currently they have no one special in their life.

Whatever your love status, one thing everyone needs to guard against at this time of year is scams.

Valentine's Day brings out the best - and worst - in human behavior. Our impulse is to be generous and search for the ideal gift. Internet thieves know this and coolly set traps for unsuspecting shoppers. And, not surprisingly, dating websites experience greater activity, along with a corresponding increase in relationship scammers.

Here are some of the more common Valentine's Day scams to avoid:

Electronic greeting cards are popular year-round, especially near holidays. Scammers count on you not paying attention when you receive an email with an innocuous subject line like, "Someone you know just sent you an e-card."

Unless you're certain someone sent you an e-card, never click on links or follow instructions to download software to open the message. Chances are you'll load a virus or malware onto your computer, dooming you to receive endless spam or even endangering your personal and financial information.

Valentine's Day is the busiest day of the year for florists. Since many people now order flowers online, these purchases are a common target for fraud. A few tips when choosing a florist:

 Make sure the physical location, contact information and fees for the florist who's actually fulfilling your order are fully disclosed.

•Pay by credit card so if there's a problem you can dispute it with your card issuer. •If you receive an email saying there's a problem with your order, call the florist to make sure it's legitimate; don't click on any links - they could be malware.

Beware of emails and social media ads touting great deals on other Valentine's themed gifts like chocolates, jewelry or lingerie. Unless you've previously done business with a company that legitimately has your email address, be skeptical. Watch out for minor typos in the web address www.macys.comm instead of www.macys.com, for exam-

It's no coincidence that dating websites are busier during the winter holidays and leading up to Valentine's Day. Lonely people's defenses are lowered, making them vulnerable to online romance scams. Before they know it, victims are conned into sharing personal or financial information, or lending money - money they'll never see again.

I'm not saying don't pursue love online at legitimate dating sites. Just watch out for these warning signs:

- •They want to move your conversations off the dating site immediately and use personal email or instant messaging the better to avoid policing by the site's Webmaster.
- •Their online profile sounds too good to be true. That's because they've probably shaped it to reflect your stated preferences. Or, conversely, their profile may be suspiciously sketchy on details or their photos don't seem genuine.
- •They profess love very quickly, even before you've spoken or met.
- •They claim to be a U.S. citizen working overseas - often in the military.
- •They make plans to visit, but are suddenly prevented by a traumatic family or business event - one which your money can overcome.




Though she made history, Col. Mary Jones did not much fanfare. expect Described as humble and soft spoken, Jones said she would not have objected to sliding quietly back to work.

He said Jones, of Jackson, has shown high integrity and dedication to her work.



Christian High School, said her mother is a role model, not only to her, but young women everywhere. They stood beside each other during the ceremony as Gloris pinned the markers to her mother's shoulders, signaling her new rank.

Jones said she simply was grateful to be serving.

October now not only marks her rise through the ranks, but also the start of her battle with breast cancer — a disease she defeated last year. She was diagnosed with the illness three years ago this month.

Retired Maj. Gen. Thomas Cutler said he thought Jones' courage, strength and faith helped her overcome the disease. But Jones said the it was the support of her family at home and in the military that carried her through the battle.

"I'm incredibly thankful just to be here," Jones said. "Everyone was so incredibly supportive and those words don't express the depth of my appreciation. They rallied around me and they strengthened me."

Jones, who helps the United States Property and Fiscal Office for Michigan manage more than \$210 million in federal appropriations and resources that support the Army and Air National Guard, has served in the military for 30 years.

She said she wanted to enlist when she was in high school, but her parents urged her not to do it. Jones did not change her mind after earning an associate dearee from Jackson Community College and attending Ferris State University and signed up.

She said she did not regret

"It's the people and the mission," said Jones, 52. "I love knowing we stand for something."

Jones said she found a new extended family in the military and couldn't imagine herself anywhere else. "It's been a long journey, and a really rewarding one," she said. "I just hope that I've given something back."



### **Despite Affordable Care Act Millions Could Go Without Health Insurance**

(FinalCall.com) - Though 2014 marks the 50th anniversaries of both the War on Poverty and Civil Rights Act, glaring racial disparities continue permeating the fabric of American society. Stark differences between Blacks and Whites in education, employment, poverty, housing and net worth, are tied to health disparities and access to health insurance coverage, according to this year's State of the Dream Report.

The report is released annually by United for a Fair Economy to coincide with the King Holiday and examines areas of racial inequality.

"Racial segregation in concentrated poverty effectively creates a toxic soup of health problems and challenges in communities of color," said Brian Miller, executive director of United for a Fair Economy in

conference call with reporters.

This year's report, titled, "State of the Dream 2014: Healthcare For Whom? Enduring Racial Disparities" zeroes in on the Affordable Care Act.

The U.S. Supreme Court upheld key portions of the ACA, dubbed "Obamacare" in 2012. But the high court's ruling also gave each state the authority to opt out of the Medicaid expansion program. The report warns this means millions will still not have health insurance.

Twenty-five states, the majority headed by Republican governors have said or indicated they will reject the expanding Medicaid, said the State of the Dream report. The federal government pays for additional health coverage offered under the Medicaid program but many GOP leaders who fought Obamacare also refuse to accept any funding linked to the program.

"This new 25-state coverage gap will leave millions of Americans without health insurance while exacerbating racial disparities in health and healthcare," the State of the Dream 2014 report warned.

If states opt out, the report said:

they were there now. She felt that members of the caucus could have done more to help Inkster residents fight to keep the district open. The Inkster and Buena Vista School Districts were dissolved in July 2013. Both districts were declared not to be financially viable by State Superintendent Mike Flanagan and former State Treasurer Andy Dillon Inkster Christians in Action President, George Williams stated that closing the schools was like "raping the community."

Earl Truss, Minister of the Wayne Road Church of Christ, asked the caucus to address the fact that citizens were now facing "taxation without representation." They were being asked to pay taxes for a district that had been dissolved and buildings that no longer belonged to them. "Why wasn't the debt dissolved with the district?" He also stated that people had "ignored the handwriting on the wall, there had been a desire to close the district since 1996."

Concern was also raised about the school buildings which were given to Romulus, Taylor, Wayne Westland, and Westwood public school systems. Since the districts aren't able to fund the maintenance of the buildings, there are plans to demolish them. Mayor Hilliard Hampton stated that Inkster High School especially needed to be saved because it stands as a symbol of pride for Inkster residents. "While the building may be old, the bones, the structure is strong."

Suggested uses for the building included a community resource center, satellite campus of an institution of higher learning, or even office space for a community based organization. While questions about whether or not the school district could and should be reopened were not answered. everyone agreed the community needed to rally together to give the leftover assets of the district, especially the Inkster High School Building, back to the citizens of Inkster. A need to change the legislation allowing the two appointed officials behind the dissolution to overrule officials elected by the people needs to be changed was also agreed upon. Several community organizations present also agreed to work together to collaborate and file a federal lawsuit.

Each legislator listened to the concerns and responded. They understood that it is going to take everyone working together to come up with viable solutions to this situa-

tion.

The session was moderated by John Johnson, Director of the Michigan Legislative Black Caucus. The persons on the panel were former Inkster Board Members -Evelyn Clark and Ruthie Williams, Thomas Stallworth -Chairman of the Michigan Legislative Black Caucus and State Representatives - David Knezek and David Nathan. The Western Wayne NAACP will compile all concerns and comments and prepare a next steps document to be disseminated to the concerned participants.

"I told the guys today, just when we were in the locker room, I'm so proud of them. I only thought there was about a threeminute period to where they showed more energy, more determination than us. You show determination, hustle for 45 of the 48 minutes, you're going to pretty successful most nights. So I told guys thought that were the big key." Well as of this past Monday, the Pistons have won three games in a row and Mr. Gores has made a statement, "playoffs or bust."

would have otherwise been covered—disproportionately people of color—will go without health insurance.

Blacks though 13 percent of the population would represent 27 percent of those who would not have insurance.

With the exception of Arkansas, every state in the South, where the majority of Blacks live, is rejecting Medicaid expansion, said Mr. Miller.

According to the U.S. Census, in 2010, 55 percent of the Black population lived in the South, and 105 Southern counties had a Black population of 50 percent or higher.

Blacks and Latinos are pushed into low income, high poverty communities where health problems, lack of access to both health facilities and full service grocery stores are common, said Mr. Miller.

Those groups are also less likely to secure jobs that provide employer provided healthcare, he added.

Medicaid is the federal and state program that provides health coverage to 50-60 million pregnant women, families, children, people with disabilities and the elderly.

To qualify for Medicaid coverage, a family can have an income that is up to 133 percent of the federal poverty level, which was about \$29,700 for a family of four in 2011. The federal poverty level is revised yearly. The federal poverty level in 2013 was \$23,550 for a family of four.

The Supreme Court ruled the federal government could not force states to expand Medicaid by withholding federal money they would otherwise receive for programs that already exist under Medicaid.

A single payer healthcare sys-

tem where government instead of private insurers pays health-care costs would be ideal but until then the ACA and pushing for Medicaid expansion is a step toward closing disparities in health insurance, said analysts that agreed with the United For a Fair Economy report.

United for a Fair Economy hopes this year's findings, when examined, will result in a better understanding of the ACA and the importance of Medicaid expansion.

"People in states that have opted out are going to say, 'Oh God, I don't have health care coverage, this Obamacare program's a failure.' Instead of blaming it on the fact that their state policy makers chose not to expand Medicaid they may unfortunately in some cases blame the original legislation and view it as a failure of that. Which it is not," said Mr. Miller.

Dedrick Muhammad, senior director of the NAACP Economic Department, was one of several policy experts that reviewed and contributed feedback on this year's State of the Dream report. Despite it being the second term of the country's first Black president, racial inequities are still very much a reality, he said. Some of the findings show racial disenfranchisement is being further cemented into society, Mr. Muhammad added.

"This really goes to the heart of what Dr. King says; of all forms of inequality, injustice in health-care is the most shocking and inhumane. We agree and that's why we wrote this report," said Mr. Miller.

An Ordinance amendment to affirm an enforcing agency to discharge the responsibility of the City of Inkster located in Wayne County, and to designate regulated flood hazard areas under the provisions of the State Construction Code Act, Act No. 230 of the Public Acts of 1972, as amended.

The City of Inkster ordains:

**Section 1.** AGENCY DESIGNATED. Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, the Building Official of the City of Inkster is hereby designated as the enforcing agency to discharge the responsibility of the City of Inkster under Act 230, of the Public Acts of 1972, as amended, State of Michigan. The City of Inkster assumes responsibility for the administration and enforcement of said Act through out the corporate limits of the community adopting this ordinance.

**Section 2.** CODE APPENDIX ENFORCED. Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, Appendix G of the Michigan Building Code shall be enforced by the enforcing agency within the jurisdiction of the community adopting this ordinance.

**Section 3.** DESIGNATION OF REGULATED FLOOD PRONE HAZARD AREAS.
