# Gunman killed during police standoff in Ecorse

At approximately 8:56 a.m. this morning, the Ecorse Public Safety Department received a complaint from an employee at June's Trailer Park on Southfield Road.

The complaint indicated that a resident was engaged in destructive behavior and had broken windows in the trailer in which he was residing and was acting distraught. The

caller stated that he observed blood at the scene.

Shortly the caller then returned to the scene then called a second time indicating the man was shooting at him. Then Watch Commander Sergeant Herring dispatched two patrol officers to the scene. They found the individual agitated, shouting obscen-

# Former Southwestern High School to be sold



The Local Emergency Financial Assistance Loan Board (ELB) today approved a proposal from Detroit Public Schools Emergency Manager Jack Martin, to sell the vacant, former Southwestern High School building. The building has been appraised at \$890,000. The sale of the property would eliminate annual maintenance costs of more than \$160,000.

The former school building, located at 6921 West Fort

Street, has been closed since June, 2012, and is in poor condition. The property has suffered significant vandalism since being closed and sustained fire damage in the building's gymnasium.

Under Public Act 436, the Local Financial Stability and Choice Act, a sale of property of more than \$50,000 must be approved by a local unit's governing body. Mr. Martin submitted his proposal to the school board on January 15, 2014.

The DPS board disapproved of the proposed sale last month and submitted an alternative proposal, which the ELB considered before making its decision today.

# Pet coke coming to Downriver?

Petroleum coke, also known simply as petcoke, has continued to plague Detroit's riverfront communities. Now it is heading to Downriver communities.

When pet coke was illegally stored on the west portion of the Detroit River, residents began experiencing a tremendous amount of nuisance, including black dust blowing everywhere and loud noises from trucks and the conveyor belt. The pet coke was sometimes transported onto the ships at 1 a.m. with large bright lights being turned on, similar to those at airports, and the noise from the conveyor belts was unbearable at that hour.

The Michigan Department of Environmental Quality (MDEQ) and the Ecology Center tested the inside of the some of the nearby homes and confirmed the presence of pet coke. The toxic metals vanadium and selenium have been found in samples taken from these homes. High amounts of vanadium can cause respiratory problems. Pet coke dust was found in air conditioning filters and in buildings as far away as half a mile from where the petcoke was being stored. The pet coke piles reached as high as 40 feet without any wind barri-

After viewing video recordings and photos recorded by residents, MDEQ recognized that the pet coke was not being properly contained. They began to order that the piles be significantly reduced. Usually piles of this type of material are more tightly regulated because they are part of a larger industrial operation

requiring strict permitting. In this case, these isolated piles were able to fly below the radar in terms of regulation. In California, after years of residential complaints, the state now requires the complete covering of pet coke piles. I introduced a bill that would require the complete covering of pet coke being stored anywhere in the state. This is a best practice, especially with the overwhelming evidence that the piles can't otherwise be properly contained. A report was just unveiled about the growing economic benefit of the transformation of the Detroit riverfront from an industrial wasteland to useable green space. It's been a tough time for communities living and doing business on or near the riverfront. This is why more redevelopment around green space and recreation activities are a better investment. Over a billion dollars in economic activity was produced after the east portion of the Detroit riverfront was redeveloped.

Marathon produces thousands of tons of pet coke as a byproduct of processing tar sands oil. As they continue to process increasing amount of tar sands oil, our riverfront communities will continue to see more and more pet coke if we don't hold them accountable for safer and better storage options. Koch Carbon, owned by right wing conser-

vative darlings the Koch brothers, purchases the pet coke and has Detroit Bulk Service (DBS) store it. The city of Detroit has already denied a permit to DBS to openly store petcoke on the Detroit River. Now the same company is coming to Downriver asking if they can be your neighbor. They already have piles near riverfront access point of Belanger Park in River Rouge, which is one of the most used public spaces in River Rouge. This is the same company that was not able to responsibly contain the pet coke piled on the west side. Downriver residents need to be engaged.

It is critical that Downriver residents record any complaints that they have with the Michigan Department of Environmental Quality, which includes reporting black dust, odors, noise pollution and other environmental related issues to 313-456-4681 and after 5 p.m. please call 1-800-292-4706.

Detroit residents took pictures, video, recorded times when they witnessed the black dust from the pet coke flying all over and beyond the fence line. I truly believe that their diligence in doing so was one of the most compelling evidence used by the City of Detroit to deny the company's usage of the property to store pet coke.

# My Sister's Keeper

In all the hoopla surrounding President Obama's "My Brother's Keeper" initiative, overlooked is that fact that our young girls also need to be targeted for special attention. Sure, they outpace Black males in college attendance and, in many instances, in the workplace. Still, that does not mean they do not also need special attention and encouragement.

Nothing illustrates this better than events of the past week. Sandwiched between President White House Obama's announcement of his special effort to help Black males and jubilation over Lupita Nyong'o winning an Oscar for best supporting actress in "12 years a Slave" was news out of Florida that Marissa Alexander, who was sentenced to 20 years in prison for firing a "warning shot" in the direction of her estranged and abusive husband, will be retried and could face 60 years in prison instead of the original

Florida State Attorney Angela Corey, the same prosecutor whose office failed to win a murder convictions against George Zimmerman in connection with the death of Trayvon Martin and, more recently, against Michael Dunn for the death of Jordan Davis, announced that instead of the 20 years originally given to Alexander, she will seek to triple that by requesting that her three 20-year terms be served consecutively rather than concurrently.

Alexander was convicted of three counts of aggravated assault with a deadly weapon in 2012 and was sentenced to 20 years under Florida's 10-20 law that requires stiffer penalties for crimes committed with guns. On appeal, the conviction was overturned because Circuit Judge James Daniel placed to burden on Alexander to prove that she was acting in self-defense. In his instructions to the jury, the judge said Alexander had the responsibility to prove that she had been battered by her husband.

In a cruel twist, the prosecutor has announced that she will reprosecute Alexander, this time seeking a longer sentence.

Marissa Alexander shouldn't have ever been prosecuted, let alone convicted. If Florida's Stand Your Ground law should apply to anyone, it should be Alexander, not George Zimmerman and Michael Dunn.

If convicted a second time, Alexander will join other Black women who make up the fastest growing segment of prisoners.

According to the Sentencing Project, the number of women

in prison increased by 646 percent between 1980 and 2010, from 15,118 to 112,797. As of 2010, more than 1 million women were under the supervision of the criminal justice system.

Black women are three times more likely to be incarcerated than White women. While most men are in prison for violent offenses, women are more likely to be in prison for drugs or property crimes. Many, like Kemba Smith, become romantically entangled with drug dealers, often serving as their "mules" to transport drugs and money.

While Florida was gearing up to triple Marissa Alexander's sentence, there was some good news out of Hollywood. The fact that Lupita Nyong'o was awarded an Oscar at Sunday's Academy Awards lifted the spirits of dark-skins girls across the country and indeed around the world. African Americans, especially females, are told in so many ways that when it comes to skin color, White is right. And if you can't be White, light is the next best thing.

Of course, there is the famous dolls test conducted by psychologists Ken and Mamie Clark, which was instrumental in the landmark Brown v. Board of Education 1954 Supreme Court decision outlawing racially segregated public schools. When asked to pick out the most beautiful doll, most Black girls selected White dolls over Black ones. When the test was repeated in recent years, the results were the same.

Muhammad Ali described racial brainwashing this way:

"We've been brainwashed. Everything good is supposed to be white. We look at Jesus, and we see a white with blond hair and blue eyes. We look at all the angels; we see white with blond hair and blue eyes. Now, I'm sure there's a heaven in the sky and colored folks die and go to heaven. Where are the colored angels? They must be in the kitchen preparing milk and honey. We look at Miss America, we see white. We look at miss world, we see white. We look at miss universe, we see white. Even Tarzan, the king of the jungle in black Africa, he's white. White Owl Cigars. White Swan soap, White Cloud tissue paper, White Rain hair rinse, White Tornado floor wax. All the good cowboys ride the white horses and wear white hats. Angel food cake is the white cake, but the devils food cake is chocolate."

Little chocolate girls are still being peppered with those White-is-beautiful images. Yes, we need to save our Black boys. But we can't save our community without saving Black girls, too.

Michigan Department of Environmental Quality, MDEQ, has scheduled in Wyandotte to share information with the residents.

Detroit Bulk Storage has applied for a permit with Michigan's Department of Environmental Quality to store the product at it's facility in River Rouge.

Although Detroit Bulk Storage has a River Rouge address, the majority of the land is zoned for Ecorse. When asked, 'Has Detroit Bulk Storage received approval to store pet coke in either Ecorse or River Rouge? The answer was no.

Many residents were unaware of this issue. However, those that knew about pet coke, were not happy about having pet coke in their backyard. Detroit Bulk Storage's location is approximately  $\frac{3}{4}$  mile from the Industrial Highway. Some of the concern is the similar to the concerns of the residents near the Rosa Parks facility in Detroit that the pet coke was stored last year .

The MDEQ has scheduled a meeting for Wednesday evening to share information and listen to resident concerns. It was held from 4pm to 7pm at the Grand Harbor Banquet Event Center in Wyandotte.

ities. As a result, the Downriver Mutual Aid Special Response Team was requested. Upon arrival they attempted to engage the individual in conversation in an attempt to talk him down.

The individual responded by firing at the armored vehicle. Then he pointed the weapon in the direction of police officers on the scene, threatening the safety of the officer. The officer fired his weapon killing Billie Joe Woolford (48) believed to be from Ohio. Mr. Wolford was declared dead at the scene. No further information is available pending a completion of an investigation being conducted by the Michigan State Police.

odds reach their full potential. The initiative will bring together private philanthropies, businesses, governors, mayors, faith leaders, and non-profit organizations that are committed to helping them succeed.

As the President said in today's remarks, ensuring that young men of color can reach their full potential is the only way "America can reach its full potential."

President Obama announced that philanthropies and corporate leaders have pledged to invest at least \$200 million over the next five years -- on top of \$150 million that they have already invested -- to figure out which programs are the most successful in helping young men of color and replicate them in communities across the country. He also signed a presidential memorandum directing the federal government to determine the best methods to improve the odds for young men of color. The President made clear, however, that government can't fix the problem by itself. Helping our young men of color has to be a multifaceted, sustained effort in all areas of our society:

In this effort, government cannot play the only -- or even the primary -- role. We can help give every child access to quality preschool and help them start learning from an early age, but we can't replace the power of a parent who's reading to that child. We can reform our criminal justice system to ensure that it's not infected with bias, but nothing keeps a young man out of trouble like a father who takes an active role in his son's life.

In other words, broadening the horizons for our young men and giving them the tools they need to succeed will require a sustained effort from all of us. Parents will have to parent -- and turn off the television, and help with homework. Teachers will need to do their part to make sure our kids don't fall behind and that we're setting high expectations for those children and not giving up on them. Business leaders will need to create more mentorships and apprenticeships to show more young people what careers are out there. Tech leaders will need to open young eyes to fields like computer science and engineering. Faith leaders will need to help our young men develop the values and ethical framework that is the foundation for a good and productive life.

So we all have a job to do.

And we can do it together --





# Money-Saving Tips for Seniors

We all love a good bargain, no matter what our age. But if you're a senior citizen on a fixed income, finding discounted goods and services can mean the difference between making ends meet and going without.

The good news is that tons of senior discounts are available – often for people as young as 50. One caveat right up front: Although many senior discounts are substantial, you sometimes can find better bargains – especially on travelrelated expenses like airfare, hotels and rental cars. So always do your research first before requesting the senior rate.

Here's a roundup of some of the best senior discounts I've found:

An AARP membership costs only \$16 a year for anyone over age 50, including free membership for spouses or partners (www.aarp.org). AARP's discounts website features discounts on dozens of products and services including rental cars, hotels, restaurants, clothing and department store chains. AARP also offers an inexpensive driver safety course for drivers over 50 (members and nonmembers alike) that can lower auto insurance premiums by up to 10 percent or more.

Popular AARP discounts include:

\*20 percent discount on installation or upgrades to ADT home security systems.

\*45 percent off membership to Angie's List.

\*20 percent off purchases from 1-800-FLOWERS.com.

\*Up to 25 percent off car rentals from Avis and Budget.

\*Up to 20 percent discount at many hotel chains including Hyatt, Hilton, Wyndham, Best Western, Days Inn and Ramada, among others.

\*10 to 20 percent off at many restaurant chains, including Claim Jumper, Denny's and Outback Steakhouse.

\*15 percent off many Geek Squad services from Best Buy. \*A free 45-minute consultation with an Allstate Legal Services Network attorney, as well as 20 percent off member attorneys' fees.

A quick Google search will uncover numerous other senior discount resources. One popular site is SeniorDiscounts.com, an online directory of more than 220,000 U.S. business locations that offer discounts to

people over 50. Registration is free, although they also offer a \$12.95/year premium that offers members-only discounts and other perks. Other good sites include Brad's Deals, Sciddy.com and Savvy Senior.

Other commonly available senior discounts include:

\*A 15 percent discount on the lowest available rail fare on most Amtrak trains for travelers over age 62.

\*Greyhound offers a 5 percent discount on unrestricted fares (over 62).

\*Southwest Airlines offers senior fares (over 65). Although not necessarily their lowest available rates, Southwest's senior fares are fully refundable.

\*The U.S. Geologic Survey senior pass (over 62) provides free lifetime access to more than 2,000 government-managed recreational sites (including national parks), as well as discounts on camping and other amenities. Senior passes cost \$10 in person or \$20 by m a i l (http://store.usgs.gov/pass/seni or.html).

\*Verizon Wireless offers discounted mobile phone service for subscribers over 65.

\*Both Walgreens and Rite Aid offer monthly senior discount days for members of their rewards programs when most non-prescription items are 15 to 20 percent off. Ask your neighborhood pharmacy if they offer similar programs.

In addition, many restaurants, department stores, movie theaters, museums, theme parks, banks, credit card issuers, utilities (including gas and electric, water, garbage, telephone and cable) and other businesses offer special discounts or promotions for seniors. Always ask before your purchase is rung up.

Bottom line: Abundant resources are available to help seniors save money on purchases large and small. You just have to do a little research – and ask whether senior discounts are available. Remember, 10 percent here and 20 percent there can really add up.



# **Ex-felony offender voting rights**

Over 5.8 million Americans are not allowed to vote because they have been convicted of a felony, regardless of the nature or seriousness of the offense. More than one-third of these people are African Americans, and while the laws vary from state to state, in some states, including Florida, Kentucky, and Virginia, more than one in five African-Americans has lost

the right to vote.

Because voting is such an integral part of being a productive member of American society, the NAACP has worked closely with other likeminded groups to develop legislation that would allow felons who are no longer incarcerated to reintegrate themselves into society and vote in federal elections. The

NAACP supports "Democracy Restoration Act," which allows ex-offenders to register and vote in federal elections as soon as they have been released from prison. We are expecting the Democracy Restoration Act to be reintroduced in the Senate by Senator Cardin (MD) and in the House Representatives by Congressman Conyers (MI) in the very near future.

I know that she has already received her refund because she posted pictures of herself on a social media site holding a wad of cash. I have also heard from mutual friends that she has already booked a vacation with the money she received. I'm furious! I don't want to be friends anymore but I do want my money back. This has put a strain on my other friendships too and I don't want to loan anyone anything anymore. In the past, I have been very generous with my family and friends but this has changed me. I'm considering suing her for the loan. At

this point, the return of the money isn't as important as the lesson she will learn by being dragged into court. Some of our friends don't agree and think that I'm being "petty". What do you think?

I wonder how many of the people whom you are generous with would be in your corner if you were unable to loan money or do the other various things that you may do for them. There is absolutely nothing wrong with being generous. In fact, to be able to live in a way that you are able to give freely is a blessing; but be wise with your giving. Be wise enough to know when you are able to be generous and when you have to say "no". Denying a request may save some valuable relationships. If this friendship is at all worth salvaging, before you take legal action, attempt to reach this friend again. Ditch texting and emailing and call her or go to her home instead. # **Detroit** strikes bankruptcy deal with banks

Detroit has struck an arrangement with two major banks that would give the city access to much-needed casino tax money.

The proposed \$85 million deal is about half a \$165 million proposal rejected in January by the federal judge overseeing the city's bankruptcy.

It would settle casino tax revenue claims from Bank of America and UBS. Struggling with pension debt, the city in 2009 pledged a portion of future revenues in exchange for a \$300 million payment. Under the deal, the banks will also support the cashstrapped city's debt adjustment plan, Detroit emergency

manager Kevyn Orr said. The settlement frees up "critical funds that we can invest to improve the quality of life in Detroit." Orr said.

Judge Steven Rhodes would have to approve Monday's deal. His January rejection of the \$165 million settlement said it would likely not be allowed to stand under the city's bankruptcy reorganization plans.

The January decision was applauded by unions, because it put the big banks in line with current employees, retirees and other city creditors.
