Review Team Finds 'Financial Emergency' in **City of Lincoln Park**

Report Sent to Governor Snyder for Review

The independent Financial cials, department heads, and Review Team, appointed February 10, 2014 to examine the finances of the City of Lincoln Park, under Public Act 436 of 2012 (Local Financial Stability and Choice Act) has submitted to Gov. Rick Snyder its report which concludes that a local government financial emergency exists. The Governor now has 10 days to consider the Review Team report and reach a determination on the financial condition of the City of Lincoln Park.

The Review Team held several meetings to consider the city's finances and conduct interviews with elected offiothers with knowledge and information relevant to the review. The Review Team also conducted a Public Information Meeting with local residents, as required by PA 436, on March 4, 2014.

The Review Team's report indicates that numerous conditions led to the determination that a financial emergency exists in the city, including but not limited to:

According to the City's 2013 fiscal year financial audit, the ending balance in the General Fund decreased

Senator Stabenow works to Protect Homeowners

Bipartisan Mortgage Forgiveness Tax Relief Act Stops IRS from Hitting Homeowners with Huge Tax Bill

WASHINGTON, D.C. - U.S. Senator Debbie Stabenow, a senior member of the Senate Finance Committee, today praised Committee passage of her Mortgage Forgiveness Tax Relief Act, bipartisan legislation that protects underwater homeowners from being hit with huge, unfair tax bills by the IRS. Her provision, included in legislation to extend expiring tax provisions (the EXPIRE Act), ensures that homeowners who owe more on their mortgages than their homes are now worth would not be hit with additional income tax if a portion of their mortgage is forgiven as part of an agreement with their lender. Without Sen. Stabenow's legislation, homeowners - for the first time since housing crisis began - would be required to pay taxes on this phantom income when they refinance or sell their homes in what are commonly called short sales.

"We should not be giving banks a tax break for the mortgage relief they offer to struggling homeowners and then send middle-class families a big tax bill," said Stabenow. "I'm glad we were able to come together in a bipartisan way to protect millions of Americans, including hundreds of thousands of people in Michigan, from being hit with an unfair tax bill so large that it could cause them to lose their homes. This legislation is a top priority and it's critical for Congress to act immediately and help the millions of families who just want a fair shot to do the right thing, get caught up on their payments, and stay in their homes."

Stabenow's amendment will extend the moratorium on taxing mortgage forgiveness through the end of 2015.

The historic collapse of housing markets from which we are still recovering has forced many families to sell their homes for less than they paid for them, and sometimes for less than their mortgage balance. Others may be stuck in mortgages that are tens of thousands of dollars or more larger than what their homes are now worth. Before Congress enacted Senator Stabenow's legislation in 2007 in response to the housing crisis, the IRS taxed loan forgiveness provided to homeowners as income, meaning underwater families were hit with a tax bill on money the family never saw. These unfair tax bills could be substantial enough to cause families to lose their homes.

At the same time, permanent tax law allows banks that are required to provide relief to homeowners to write

off the costs from their taxes.

Senator Stabenow championed the original legislation that protected homeowners from this tax on phantom income. However, that legislation expired at the end of 2012. Senators Stabenow and Dean Heller (R-NV) led a bipartisan group of senators in introducing legislation last year to continue this protection for homeowners through the end of 2015. Companion legislation in the House has wide bipartisan support but the Wavs and Means Committee has not acted upon it.

According to the Urban Institute, the Mortgage Forgiveness Tax Relief Act has provided tax relief to more than 7 million families. With an estimated 6.4 million homeowners still underwater on their mortgages—including 250,000 Michigan families—it is critical that the law be extended to provide certainty to families, our housing markets, and our overall economy.

The legislation is supported by industry and consumer groups alike - from the National Association of Realtors and Mortgage Bankers Association, to more than 200 communitybased groups and consumer organizations, like National Consumer Law Center. 42 of the nation's attorneys gener-Democrats Republicans, have also joined in calling upon Congress to act quickly on this legislation.

from \$2.0 million as of June 30, 2012, to a negative \$89,803 as of June 30, 2013. This \$2.1 million net change in fund balance resulted from General Fund expenditures exceeding General Fund revenues by \$2.3 million, which was slightly offset by a transfer into the General Fund of \$166,666.

* A trend of over-spending from the General Fund. As recently as June 30, 2010, the ending balance in the General Fund was \$4.5 million. Therefore, in just three fiscal years (2011 through 2013), City officials depleted a \$4.5 million fund balance in the General Fund.

*City officials indicated that the General Fund deficit likely will increase by an additional \$1 million during the current fiscal year, which ends June 30, 2014. City officials indicated this estimate to be a best-case scenario, assuming the City will receive financial concessions from its police unions. In the event such concessions are not realized, the deficit for the current fiscal year likely will be significantly greater.

The Audacity of Voting

i love voting. Every time I go into the booth, I see little girl me, pigtails and all, plaid skirt, white blouse and green sweater, part of my Catholic school uniform. Most of my relatives were Democrats, though my grandmother voted Republican a time or two because "Lincoln freed the slaves." In 1960, I had the privilege of pulling the lever to John Fitzgerald elect Kennedy, the candidate that the nuns at Immaculate Conception Elementary School rhapsodized over.

On the way back from the polls, my mom told me that Negroes (as we were called then) didn't always get to vote, and she shared facts about grandfather clauses and poll taxes. I'll never forget that moment, which may have sown the seeds of my activism. Indeed, when I went to school the next day, and the nun asked if everyone's parent had voted, I took the opportunity to share that Negroes did not always get to vote. I was sent home with a note at the end of the day, and got an admonition from my mom about keeping my big mouth shut. I guess I didn't learn my lesson.

I guess everyone doesn't like voting as much as I do. Only a quarter of those eligible to vote in the District of Columbia did so. Some blamed the earliness of the primary (only Illinois had an earlier date, on March 26, and some states have primary elections as late as September); others spoke of the inclement weather the weekend before the election as affecting voter turnout. But when I am reminded that Fannie Lou Hamer was almost beat to death because she registered voters, and Medgar Evers was killed because he worked to secure voting rights for Black people, I am infuriated by those who take a pass on voting. How does a little snow on Sunday keep you from going to the polls on Tuesday? The fact is that too many African Americans play into enemy hands whenever they fail to vote.

Now the Lawyers' Committee for Civil Rights under Law (www...lawyerscommitt.org) has produced a "Map of Shame" that highlights more than a dozen states that engage in voter suppression, either by requiring picture ID,

consolidating polling places so that people have to travel further to vote, or passing other restrictions on voting.

Unsurprisingly, most of these states are in the South, but Northern states such as Wisconsin, Indiana, Ohio and Pennsylvania have also made it more difficult for voters. North Carolina is so bad that Rev. William Barber, head of the state NAACP, has been leading hundreds outside the state capitol weekly for "Moral Mondays" design to draw attention to the immorality of voter suppression.

In a recent decision, the Supreme Court has now made it easier to purchase votes on First Amendment grounds, with the amount that the wealthy can give increasexponentially. McCutcheon v. Federal Election Commission, the court ruled that the limit on contributions is unconstitutional. McCutcheon is not shy about explaining why he wants to spend more money. He wants to ensure that the law embraces conservative principles.


It is interesting that the McCutcheon decision comes in time to influence this election cycle. With this decision, the Supreme Court has made it easier to purchase an election. With limits on PAC money lifted, the court has created a well-funded monster. There is more than one way to suppress the vote, and this court is determined to silence citizens any way they can. They have nullified a key section of the Voting Rights Act. They've made it possible to pour money into campaigns. In many ways they have attempted to shut people up, or at least skew the playing field in favor of the wealthy.

Rev. Jesse Jackson says that the hands that picked peaches can also pick presidents. We can't pick anything if we don't get to the polls. Voter suppression and well-funded opponents are obstacles to voting. Still, we impose some of the obstacles on ourselves.

Ficano urges MDEQ to deny permit allowing storage of pet coke in River Rouge

Detroit, MI – Wayne County Executive Robert Ficano voiced strong opposition to the possible granting of a permit to store pet coke by Detroit Bulk Storage at its headquarters in River Rouge, MI.

In a letter to Dan Wyant, the Director of the Michigan Dept. of Environmental Quality (MDEQ), Ficano said windblown particles would negatively impact the quality of life for residents and businesses in the area of 530 Great Lakes Street, the proposed storage site in River Rouge.

"I have received numerous communications expressing concern about pet coke transport and storage Downriver," Ficano said in the letter to Wyant dated April 1, 2014. Petroleum coke, also known

as pet coke, is a fuel source that is a byproduct of the coking process at petroleum refineries. It is often burned as fuel in cement kilns and power plants.

Detroit Bulk Storage is seeking a Permit to Install (also known as a PTI) from the Air Quality Division (AQD) of the MDEQ. The submitted application is currently under review. The MDEQ will make a preliminary determination on whether Detroit Bulk Storage's application can comply with existing laws. Should the application be moved forward, the measure would face further examination including a public information meeting and public hearing.

In his letter to the MDEQ, Ficano asks the agency to provide updates and notice of the permitting process to the Wayne County Executive Office and the Wayne County Department of Public Services, Environmental Services Group so that Wayne County can be fully engaged in the process.

For much of 2013, the storage of pet coke along the Detroit River created a hornet's nest of controversy. A coalition of residents, politicians and environmental supporters successfully had a three-story pile of the product moved from a location in southwest Detroit.





MDCH Notifying Individuals regarding Health Information Breach Laptop stolen



LANSING – The Michigan Department of Community Health (MDCH) recently became aware of a breach of protected health information under the Health Insurance Portability and Accountability Act (HIPAA) and is notifying 2,595 individuals and the Department of Health and Human Services regarding this breach.

On the evening of Jan. 30 or early morning Jan. 31, a laptop computer and flash drive were stolen from an employee of the State Long Term Care (LTC) Ombudsman's Office. Information on the laptop was encrypted; however, data on the flash drive was not and contained sensitive information regarding participants that the LTC Ombudsman's Office serves. The flash drive contained personal information about 2,595 living and deceased individuals, including names and addresses, and for some individuals, dates of birth. Of those, 1,539 records also

included either a Social Security number or a Medicaid identification number.

"MDCH takes any potential breach of security with the utmost seriousness and sincerely regrets that this breach occurred," said Nick Lyon, Chief Deputy Director of the MDCH. "We are working swiftly to notify any individuals who may have been impacted and with staff to tighten our security procedures going forward."

The theft has been reported to the police, but, to date, the laptop and flash drive have not been recovered. MDCH learned about the breach on Feb. 3and notified impacted individuals this week after reconstructing the data.

All individuals with data on the flash drive are being notified so that they can monitor their accounts and other financial affairs for any unauthorized use. MDCH is working with the LTC Ombudsman's Office to offer credit monitoring services at no cost to people whose Social Security number or Medicaid number were compromised. In addition, a credit file death suppression service is being offered to the families of deceased individuals to assist them in securing their deceased loved one's credit

and wish to take action to protect yourself from potential identity thieves, you may place a fraud alert on your credit file. A fraud alert tells creditors to contact you before they open any new accounts or change your existing accounts. You can place a fraud alert on your credit file by calling any one of the three major credit bureaus: Equifax: (800) 525-6285; Experian: (888) 397-3742; Trans Union Corp. (800) 680-7289.







UConn Beats Kentucky to Claim Fourth National Title



(Via Washington Post) – Led by one of a dying breed in college basketball, a NBA-worthy point guard who stayed in school for his senior year, Connecticut toppled a Kentucky team that had cornered the market on teenage talent to claim the school's fourth NCAA championship on Monday.

Senior Shabazz Napier (pictured) did nearly everything for his Huskies at AT&T Stadium, scoring a game-high 22 points, directing the offense and controlling the tempo in Connecticut's 60-54 victory before a NCAA championship-record crowd of 79,238 that included past presidents George W. Bush

and Bill Clinton looking on as giddy seatmates from a luxury box.

It was Connecticut's fourth national title in the last 15 years and its least probable. The Huskies became the lowest seed, at No. 7, to win the national championship since Villanova in 1985. And their triumph followed a one-year ban from the postseason because it had fallen short of the NCAA's minimal academic standards. "This is what happens when you ban us!" a jubilant Napier said into a TV camera as confetti rained around him, explaining later that the Huskies hadn't been driven by revenge so much as hunger.

Michigan Women: Women are not worth-less, it's time for equal pay

April 8 is National Equal Pay Day



LANSING - On Tuesday, April 8, Equal Pay Day will be recognized across the country. The day marks how far into 2014 a woman must work, on average, to earn as much as a man earned in 2013. The gap between the wages of men and women is even greater for women of color. According to AAUW's Graduating to a Pay Gap, sex-based wage disparities start with a collegeeducated woman's first job and increase over time. Since more women than ever before are the sole or primary source of household income, the wage gap is a serious issue for the economic security of families.

At an April 1 U.S. Senate committee hearing on the Paycheck Fairness Act (S. 84), American Association of University Women of Michigan (AAUW of MI) member Kerri Sleeman bravely shared her experience of learning that men she trained and supervised were being paid more than her – simply because they were male breadwinners.


Sleeman traveled to Washington, D.C., for a whirlwind trip – lasting fewer than 24 hours! – to drive home the message that no one should be paid less than their value and it's long past time for our lawmakers to do something about gender pay discrimination.

"If the Paycheck Fairness Act had been the law, I would have talked about my salary without fear, and I likely would have known where I stood in comparison to the men I worked with and those I supervised," said Sleeman. "Instead, without the Paycheck Fairness Act, I wasn't able to ask, and I made less."

The Federal Equal Pay Law passed 51 years ago so it is surprising that the latest federal government data indicate women's median annual earnings for full-time work was 77 cents for every dollar men made. It is time for the disparities to end by strengthening our laws nationally and in Michigan.

On Tuesday, April 29 at noon in the Michigan Capitol, the day both houses of the Michigan Legislature return from their spring break, the Michigan Equal Pay Day Coalition will call on lawmakers to pass legislation to ensure that Michigan's women are paid the same as their male counterparts for comparable work. A package of legislation was introduced in the Michigan Senate and House last year and is awaiting action. Advocates will hand out chocolate chip cookies with a "bite" taken out to symbolize the pay disparity. Speakers will be available for individual interviews following the event.



In select schools, in addition to spending time in the driver's seat of parked 18wheeler to fully comprehend its massive blind spots, teenagers witness the violent detonation of an air bag, which reinforces proper hand placement on the steering wheel.

Students are taught in their own cars, not specially prepared program vehicles, so the skills they learn can be directly translated to their daily driving experiences. Tire Rack Street Survival® challenges teenagers to understand how to control a vehicle, rather than just operate one.

Tire Rack Street Survival® is open to licensed and permitted drivers ages 15 - 21. Forms, schedules and more information can be found online

www.streetsurvival.org. The cost is \$75 per student and some insurance companies offer premium discounts to graduates.

The program in entering its 12th year having trained 12,000 new drivers. 101 schools were completed last year and the goal for 2014 is over 110 nationally.

For the 5th year, Michelin North America is supporting the Street Survival program by providing funding for pavement rental for each school throughout the United States. That is no small task, given that this year the Tire Rack Street Survival schools plan to offer its training to teens all across the U.S.
