Our Christmas celebration party was a big success again this year, and attendance at our New Year's celebration exceeded our expectations. With more than 110 members and guests in attendance at our New Year's Pig Roast, seating was short, but we thank you all for your patience as we added more tables and chairs that evening. With the Board's action at the January Board Meeting, we will be purchasing more tables and chairs so that we can continue to host these and other well attended events. A special thank you our facilities Supervisor, Tom Hall, who gave up a night's sleep to help cook the pig. Also a special thanks to the Keg Bar for allowing us to borrow their cooker for the pig. I am happy to report that we closed last year in a strong financial position, with a surplus of \$103,000 being rolled over for our future needs. This funding will allow us the option of completing the remaining clubhouse exterior renovations, and also allow us to set aside funding for the eventuality of a costly repair/replacement of our pool. With the age of our existing pool, such a replacement is becoming ever more likely in our future. We plan to repair and maintain the existing pool as long as we can at a reasonable cost. However, in the eventuality that replacement becomes a more feasible and financially prudent option, we must have some money set aside to offset that large expense.

At our meeting in January, the Board appointed Laura Hart-Smith to fill the vacancy on the Board left by the resignation of David May. Laura and her family are new members in our community, and were drawn to EFPOA by the recreational qualities of our community. Laura is interested in seeing that our rules and regulations, maintenance, and financial stability protect and improve our facilities for all. Please welcome Laura and her family, and thank her for volunteering to fill the vacancy on the Board.

No Change in Dues for 2016

You may have to go to more than one monthly meeting, but be persistent! <u>The meeting</u> <u>dates are: February 18, March 17, April 21, May 19 and June 16 and</u> <u>every third Thursday the rest of the year</u>

Doing this is against state regulations (See Public Act 82 of 1978, Section 257.677A) that states individuals are NOT to "deposit snow on any roadway." If caught doing this, it is a misdemeanor with possibly 90 days in jail and a \$100 fine!
