## Reduced Dues Date Moved Earlier

The date for getting the reduced dues rate has been moved up to February 14th from the previous March 1st date. This change was approved by the EFPOA Board of Directors at their last meeting on December 1st and will help EFPOA's cash flow challenges as we enter our new budget year. To get the reduced rate of \$280, the check for the full amount must be post marked by February 14th, 2013. After this date, the dues rate returns to the full rate of \$340 and can be paid as one payment by March 1st or in two payments of \$170 due March 1 and Sept. 1, 2013. For guestions, contact Chris Dorsten, Treasurer (989.732.7467). Please note also that monthly dues payments will NOT be allowed beginning with this next dues cycle. This change was approved by the EFPOA Board at their Sept. 29th meeting. The Treasurer has also announced that we will no longer accept cash payments for dues. Checks or money orders are all that is accepted; the Board is looking in to PayPal and other options for the future.

# From the President

Whether you celebrate Christmas or Hanukah, we hope this holiday season will be a memorable one for you and your family. We hope you will use this season to reflect on your blessings and to renew your hopes and dreams. May 2013 be your family's best year ever!

"We wish you good health, peace and prosperity in 2013!" Al Gamicchia - Some of you who don't live up here may not have heard the news yet that EFPOA lost a good citizen last month when board member Al Gamicchia passed away. Al was a good neighbor and loved Guthrie Lakes. He served several terms on the board and was vice president of a previous board. Al's devotion to improving EFPOA will be missed. If you haven't done so already, please offer your condolences and a helping hand to Al's wife, Gail. There is a memorial to Al on the EFPOA website and a toasting to Al is scheduled for January 12, 2013, his birthday.

**Board vacancy** - The board had a vacancy due to Al's untimely passing. At the December 1 meeting, the board voted to have Mr. Ron LeBourdais complete the final seven month's of Al's term. Ron has owned property in Enchanted Forest for many years. He and his wife Mary Kay are full-time residents. Ron has donated many hours of his time to improve the electricity and lighting at our clubhouse. He's level-headed, honest and fair.

Committee vacancies - The chairs of several committees have asked for volunteers who are willing to serve. Tony Esson needs volunteers for the Deeded Restrictions Committee. Brian Wilson needs volunteers for the Rules and Regulations and By-Laws Committees. George Leinerth needs volunteers for the Building and Grounds Committee. Matthew Mogle needs volunteers for the Security Committee. EFPOA is a better place for all its residents when people see a need and volunteer to help. Please be a "giver" during this holiday season and volunteer to serve on one of EFPOA's committees.

The Lyric - This is the last "regular" edition of *The Lyric* that will be sent out by mail to all of our property owners. Editions that publish elections will continue to be sent out in the spring of each year. In a cost-cutting move, the board has voted to try an online version that will be posted on the EFPOA website <a href="www.efpoa.com">www.efpoa.com</a>. There will be a downloadable version of it available in the future on the website for those who prefer to read a hard copy. Members with an email on file with the EFPOA will receive a copy as an email attachment. The board also agreed to make exceptions for those who do not have internet access. If you fall into that category, please notify the EFPOA manager in writing, and we will continue to mail you a copy.

**Dues delinquent property owners** - At the last board meeting, the board voted to enforce a long-standing rule that property owners who are delinquent on their dues are not permitted to use EFPOA amenities. The board clarified the meaning of "delinquent" to include those owners who are behind on their dues but are still making payments. The EFPOA will continue to honor terms and conditions on previous EFPOA Board approved payment agreement form previously accepted.

Small Claims - The board has directed the manager to begin an aggressive effort to collect delinquent accounts. Beginning in 2013, our manager will start filing papers in Small Claims Court to collect arrearages. In Small Claims Court, the magistrate can authorize the garnishment of wages or bank accounts to settle unpaid dues.

If you are delinquent, please make immediate arrangements with the manager or treasurer to take care of your obligation. Failure to do so may result in your being taken to court.

**Finances** - At the December 1 meeting, the board considered options to get EFPOA out of its current cash crisis. Options included taking out a new mortgage, offering notes to property owners, curtailing expenditures, and cutting or eliminating the discount for early payment in full.

After considerable debate and plenty of input from property owners, the board decided not to reduce the discount for early payment for 2013. That option remains on the table for future years.

However the board did shorten the early payment period to February 14. If you wish to receive the discount on your property or properties, your payment in full <u>MUST BE POSTMARKED BY</u> FEBRUARY 14, 2013.

The president and treasurer were directed by the board to investigate a mortgage that would cover the outlays made for repairs and improvements in 2011 and 2012 as well as potential costs of still pending improvements such as carpet replacement and completion of the siding project.

Obtaining a mortgage that covers those past expenses and possible future ones would allow EFPOA to replenish its cash on hand. The bank account was depleted when the board elected to pay cash rather than borrow for the improvements in 2011 and 2012.

Last year EFPOA ran a \$65,000 deficit. This year, it will be about \$50,000. For the past two years, we've operated for four or five months at the end of each year on a line of credit. Without the cash outlays for improvements, EFPOA would have had a very modest positive cash flow for 2011 and 2012.

I do want to make clear the reasons EFPOA finds itself in this cash-strapped situation:

- 1. There was a lingering legal situation that went on for about 8 years and cost over \$50,000.
- 2. Expensive repairs and maintenance had to be done, including the roof, the pool, removal of the fireplace pit, and the rear siding in 2011; and the boat ramp, electrical and painting in 2012. These repairs and improvements totaled more than \$105,000.

EFPOA's boards historically have been frugal. But eventually a time comes when projects cannot be postponed. That was the case in 2011 with the crumbling pool and leaking clubhouse roof; it was the case in 2012 with the Legend Park boat ramp. Presently the clubhouse has siding that is literally rotting away in places. And it has no insulation in the basement ceiling.

There is no simple answer to how we alleviate the cash flow situation. The line of credit, in my opinion, has been a band-aid approach. Alternatives are a special assessment, elimination of the early payment discount, or a mortgage. At this time, it appears most board members favor the mortgage option.

**Boat Ramp** - The board promised boaters in 2011 that the boat ramp would be priority #1 in 2012. It took longer than anticipated to get the permit approved and the contractor out here to do the job, but it's finally done and looks good.

Lots available - If you know anyone who is interested in becoming a part of our community, please let them know that EFPOA has several lots available for purchase. We have not placed a set price on these lots but will consider any reasonable offer. The idea is to convert these lots into dues generating properties.

With the recent passage of the recycling millage, our county will soon have five 24-hour drop off sites available to residents. We've heard one will be close to Waters! The county hopes to have these operational by this spring. In the mean time, for those of us who like to help the environment and "live green", here are some reminders about where and how you can recycle between now and spring at no cost...for FREE! (PS - We heard that Goodwill is NOT taking recyclable items anymore.)

HOURS OPEN: Tues & Thurs 2 - 7 pm, Sat. 9-4, Sun 12N to 5 pm. Located just west of I75, north side of road; see sign on chain link fence just west of baseball field. Toot your horn at the garage door, drive in to garage; they will unload from your trunk; great service!! 989.348.3195

NOTE: Besides Plastics #1, #2 and milk jugs, they also accept newspapers (+ phone books, & catalogs), flattened cardboard, rinsed tin & aluminum cans (no labels), styrofoam, egg cartons, meat trays, auto & AAA batteries, brush & trees <6" diameter).
