Data breach – This month there were 2 articles about data breach of consumer personal information that may impact you.

Equifax – The Equifax security breach was announced in 2017. Equifax has come to a settlement with the federal government of what they need to do for consumers who were impacted. You may be eligible if your information was compromised. It is highly likely that your data may have been breached given that Equifax says it impacted more than 147 million people. Capital One – This was just announced this month that an employee at Capital One was able to hack into data of Capital One credit card consumers. The company is saying that they do not believe the employee wanted to access consumer data for criminal purposes but just to see if she could hack the system. This is a very new story so Capital One has not yet notified customers and has not said what they will do for consumers impacted.
