ADOPTION AGREEMENT

The following binding legal agreement between AZ Pug Life Rescue Society ("AZ Pug Life Rescue", "APLRS", "we") an Arizona non-profit organization, and you, _____ herein referred to as the "Adopter" or "you" agree to the following:

We are placing the dog (the "dog") described on the attached Medical Record with you, the Adopter, for adoption as an indoor pet. Dog's Name: _____. We require an adoption fee of \$_____ for the dog. There are no refunds, if the dog is returned within 7 days, the adoption fee will be converted to a tax deductible donation provided said dog is returned in the same physical condition as when adopted.

_____ You understand that this dog was previously unwanted or lost and we may have no history on this dog. You agree that we are making no representations or warranties about the condition, personality, age or temperament of the dog.

_____ You have observed and examined said dog and as of the signing of this agreement you accept the condition of the dog. All future medical, veterinary, grooming and related expenses of the adopted dog are the responsibility of the adopter. APLRS is not responsible for any expenses relating to the adopted dog as of the signing of this agreement.

_____ You agree to provide the dog with space inside your home, affection, clean water and quality dog food. You will never leave the dog outside, alone in warm weather as dogs (in particular pugs) can easily overheat. We highly recommend you never allow the dog to roam free and comply with local leash laws and ordinances.

_____ You agree that you will never sell, trade, or give away the dog. You agree never to surrender the dog to an animal shelter of any kind. You, further agree if you are unable or unwilling to keep this pet, you will return the dog to APLRS. If the dog is found to be abused or neglected one of our remedies will be to recover the dog upon demand.

_____ You agree that you will not euthanize the dog except in the case of the dog's terminal illness or injury, or old age accompanied by pain and suffering and is in the best interest of the dog. Euthanasia must be performed by a licensed veterinarian.

_____ You agree that if you fail to comply with the terms of this agreement that you will voluntarily surrender the dog AZ Pug Life Rescue. You agree to pay AZ Pug Life Rescue the sum of \$1000.00 as liquidated damages in the event the terms of this agreement are breached to compensate us for our costs. You agree to pay all court costs and attorney's fees incurred by APLRS in addition to the \$1000.00 if necessary to enforce this contract.

_____ You have voluntarily agreed to adopt this dog and fully accept the risk, with this in mind, you agree to waive, release and covenant not to sue over any and all rights or claims for damages, injuries, costs, or liabilities.

_____ If a check is issued as payment for adoption of said dog and is returned due to insufficient funds, or bank failure to honor the check Adopter agrees to immediately make right the entire payment plus subsequent insufficient fund charges with cash or relinquish ownership of said dog back to AZ Pug Rescue Society.

_____ If any term of this Agreement is to any extent invalid, illegal, or incapable of being enforced, such term shall be excluded to the extent of such invalidity, illegality, or unenforceability; all other terms hereof shall remain in full force and effect.

Any monies in addition to adoption fees are tax deductible as allowed by law.

You the undersigned have read, understand, and agree with the terms of this legal, binding agreement. No modifications of this Agreement will be valid unless in writing duly signed by both you and an Executive Officer of AZ Pug Rescue Society.
