MEMBERSHIP ELIGIBILITY

*The below information is an excerpt from Article III of the McChord Spouses' Club Constitution.
Please read the below to determine what type of membership you are eligible for.*

Section 1: Membership in the MSC shall be voluntary, for one year, (1 August through 31 July) and is extended to:

A. Active Members:

1. Eligibility:
 - a. Spouses of all Active US Air Force ranks, who are on permanent or temporary assignment to McChord Field.
 - b. Spouses of all Reserve US Air Force ranks.
 - c. Spouses of all Retired US Air Force ranks, who reside in the JBLM area.
 - d. Spouses of civilian employees, who are employed on McChord Field.
 - e. Spouses of Allied Armed Forces assigned to McChord Field.
 - f. Spouses of all active Air Force ranks, who are on permanent or temporary assigned to JBLM.
 - g. Spouses of Active Air National Guard personnel.
 - h. Spouses who reside in the JBLM area, whose Air Force sponsor is serving an unaccompanied tour.
 - i. Un-remarried widows of US Air Force personnel who reside in the JBLM area.
2. Privileges:
 - a. Active members shall pay dues, **have the privilege to vote, to hold elected or appointed offices**, and to participate in all MSC social and welfare activities.
 - b. Active membership is effective upon registration and payment of current dues.

B. Associate Members:

1. Eligibility:
 - a. Un-remarried widows of Military personnel who reside in the JBLM area.
 - b. Spouses of Retired Military Personnel who reside in the JBLM area.
 - c. Adult dependents of Active or Reserve members, regardless of branch of service.
 - d. Civilian employees, who are assigned to McChord Field.
 - e. All active duty and retired US Air Force personnel assigned to McChord Field.
2. Privileges:
 - a. Associate Members shall pay dues and have the privilege to participate in all MSC activities except Associate members **may not vote or hold elected office, but may hold committee positions**.
 - b. Associate membership is effective upon registration and payment of current dues.

C. Honorary Members:

1. Eligibility:
 - a. The President, in conjunction with the Advisors shall invite other individuals to be honorary members upon approval of the majority vote of the MSC Executive Board.
2. Privileges:
 - a. Honorary Members will enjoy all the privileges of active members with the **exception of voting and holding an elected or appointed office or committee chairmanship**. Honorary members will not be assessed dues.
