One of our goals at RGMF is to make this experience as enjoyable and unique as possible. There are MANY Renaissance faires scattered throughout the US. Yet, to our knowledge, we're the FIRST German based faire. Because of this, we'd appreciate an **attempt** at German looking garb, please.

#### **Vendor Parameters:**

All Vendors will need to bring their own tents, tables, chairs etc.... Concerning the tents, please wrap the tent poles. If you wish to decorate the tents with decorative fabrics, we encourage that to further enhance the festive spirit of the event!! ALL VENDORS MUST have an **attempt** at Medieval Garb. If you can make it look German, that would be greatly appreciated. Please send photos of your garb and craft items with your application. Thank you.

Friday October 14<sup>th</sup>, 2016. We will be open for school day 9:00am-3:00pm however we will remain open until 9:00pm for some entertainment and craft beer, wine and mead tent. Vendors will be allowed to stay open if they wish.

Saturday, October 15, 2016. We will be advertising an "Under the Stars Masquerade Ball." A Beer, wine and mead tent will be open during the event. We are not requiring our vendors be open at this time. PLEASE indicate if you are staying open on the vendor application, so we can advertise your booth

closer to the event (No extra charge for staying open during the masquerade ball). Since we will be open in the evening. Please let us know about your electrical needs. Every outlet requested will be \$20.00 per. The Masquerade will go from 6:00pm-10:00pm.

For the other vendors who will not be open during the Ball, please keep in mind that people will continue to be on the grounds until 10:00pm, and it will be difficult to secure all of your booths during this period. Please take the necessary precautions to make sure that your items are away and safe. Again, thank you in advance.

Sunday, October 16th, 2016. We will be open from 11:00am-6:00pm

## Craft vending Fee:

Friday October 14, Saturday October 15, Sunday October 16, 2016: \$60.00 for 10 x 10 space, plus \$20.00 per electrical outlet. Set up for booths can start Thursday October 13<sup>th</sup>, 2016. We also ask for a **donated** craft item to help fundraise for this event.

Fires are permitted, however no fires are allowed to be built directly on the grounds of the park. A safe reciprocal that was made to retain fires must be used and insurance provided. Kerosene lamps, torches and candles will also be allowed for ambient light during night time vending, again insurance and common sense must be provided for the use of fire on premises. If we feel a fire reciprocal is unsafe, we are allowed to ask you to replace or put out the fire. Your understanding a head of time is greatly appreciated.

Camping is allowed on site for vendors. If you are not camping inside your vending booth, the sleeping tent must look period. All mundane or modern items must be hidden inside tent during the time of the event. Please indicate additional space on application. We will not charge you for none vending tent space. However, if you ask for electric to come to your tent, we will have to ask \$20.00 to cover electric, per unit. Sorry for the inconvenience. RV Parking is also permitted on grounds for vendors and performers only.

#### Food vendors:

Friday, October 14<sup>th</sup>, 2016 is a school day. Your participation is required on this day, we're busing children in for educational instruction. Last year we had approx. 3,000 attendee's.

### Food vendors Fee:

October 16-18: \$35.00 fee + \$20.00 per electrical outlet requested (this includes after hours vending on Friday October 14 (after school day from 5:00-10:00pm) October 15 (6:00pm-10:00pm) Under the Stars Masquerade Ball + 10% of all proceeds.
