Of course, increasing attendance at these conferences is always the surest bet to generate a profit or break-even. For our next conference in Frederickburg, we will also be making a concerted effort to get corporate sponsorships. This will help our bottom line. While on the subject of bottom lines, our bank balance as of November is \$19,238.94.

Blue Santa

he Victoria County Juvenile Probation Department and 10-juveniles partnered up with the Victoria Police Department (VPD) by participating in the Blue Santa Project "Stuff the Truck" event. At this event, which was held on December 6th and hosted by a local H-E-B and sponsored by VTG (KAVU) & KIXS 108, the community was able to drop off new or unwrapped toys.



The Blue Santa Project is made up of volunteers from the VPD, the Victoria Police Officers Association, Victoria Civilian Police Academy and members of the community. The project goal is to provide gifts and clothing to underprivileged children in our community at Christmas time.

The Blue Santa philosophy is that all children deserve to smile on Christmas day. Christmas is one time during the year where the focus is on giving, with emphasis on the excitement in the child's eye as he or she unwraps a present that is just for them.

Why Blue Santa? It has been said, "No one calls 911 to tell police that all is well with their lives." In the course of police officers' routine work, they often encounter children in circumstances and environments that are heartbreaking. Many of the children that police interact with only know Christmas as nothing more than a school holiday. Many families must choose between gifts and basic utility needs, leaving little resources for presents at Christmas time. Regardless of the whys, all children deserve presents at Christmas.

Featured Work Site

he Valley Community Food Pantry is administered by the Valley Community Foundation (VCF) located in El Paso, Texas. Groceries are provided to people who are referred by over 100 agencies for emergency need.

The pantry has been in the Lower Valley for the last 14 years serving the community. In that period of time, the food pantry has served over 7,750 families and 10,000 persons. It has done this in partnership with the El Pasoans Fighting Hunger Food Bank to help with people's food insecurity.

VCF is a grant funded non-profit organization. Currently, three projects are ongoing by the Valley Community Food Pantry:

- the pantry itself;
- a program called Valley Community Food Pantry On The Go, where instead of people coming to the pantry to pick up a bag of groceries, bags are delivered to the people (elderly, low income families, mentally challenged, disabled, veterans, migrant farm workers) in different outlying areas of the city; and,
- the Fresh Start Closet that helps people in need of proper clothes to go and interview for jobs.

Additionally, the pantry offers opportunities to those groups that are interested in doing community service (Juvenile Probation Department, High School organizations, Service Sororities, Adult Probation Department). The Valley Community Food Pantry future is to become self-sufficient and to help those in need achieve sustainability for their families.

The grant awarded by The Texas Community Service Association to The Valley Community Food Pantry will help the pantry develop and implement sustainability programs for its families.
