Conference Update

On February 26th, the TCSA Board held its 2015 Conference Planning Meeting in Fredericksburg. The board voted to select the Inn on Barons Creek as the host hotel. This ninety room hotel is located two blocks from Main Street. It sits on four scenic acres with a pool and complimentary deluxe continental breakfast.

In the event that more hotel rooms are needed, the board also selected the Fredericksburg Inn & Suites Hotel as the secondary hotel. This 103-bed hotel is located directly across the street from the host hotel.

It is expected that all training and events will be held at the host hotel. The only exception is that we will hold our complimentary luncheon at the Fredericksburg Inn. You will not be disappointed with the service and scenery at either of these venues.

Fredericksburg is centrally located. It is only seventy-seven miles southwest of Austin and seventy miles northwest of San Antonio. It has plenty of small town charm with all the amenities of a big city. Established in 1846 by German pioneers, Fredericksburg is nestled in the Hill County with several historic sites and museums that recount its rich history. Additionally, there are countless art galleries, shops, wineries, and much more.

Planning for the conference will continue with efforts headed by Domingo Sanchez, Gillespie County Sheriff's Office, who is the 2015 conference chair. The conference is set for November 8 – 11.

The conference agenda is still in the finalization stages; however, we already have most of the presenters committed. Fredericksburg Mayor Linda Langerhans will welcome conference attendees. Other speakers include, but are not limited to, Christopher Nevins, Gillespie County Attorney (Legal Liabilities); Dr. Jeannine Von Stultz, Bexar County Juvenile Probation Department (The Adolescent Brain); Conrad Jones, Texas Juvenile Justice Department (Abuse, Neglect & Exploitation); and more.

n 2014, <u>CriminalJusticeDegreeOnline.net</u> sought to answer the question: "What's the best online criminal justice program?" Four online programs surfaced. In rank order, they are: 1) Washington State University, 2) Arizona State University, 3) Sam Houston State University, and 4) Penn State World Campus.

The article goes to great lengths to explain its research methodology. It mentions how over 40 professors helped create a methodology that was used to narrow a list of 107 programs down to the top four in the nation. An article bonus is that it also identifies what it considers to be some of the worst programs.

GYSD Mini-Grant

On March 16th, the Texas Juvenile Justice Department announced its 2015 mini-grant recipients for Global Youth Service Day (GYSD). Youth Service America provided \$ 2,750 in planning grant funds. TCSA provided an additional \$250 in grant funds for its members. The State Volunteer Resource Council manages the mini-grant application and disbursement process.



Ten entities, including juvenile probation departments, parole offices, state schools, state correctional facilities, and halfway houses, were selected as recipients of mini-grants. Potter County Juvenile Probation Department received the TCSA mini-grant.

Membership Change

At the 2015 Conference Planning Meeting the board also voted to change membership criteria. Membership and ability to hold office used to be limited to those individuals employed by Community Supervision & Corrections Departments and Juvenile Probation Departments. This list has been expanded to those employed by or affiliated with CSCDs, JPDs, parole services, law enforcement, non-profits, and independent school districts.
