Jimmy Don Nicholson, HTR, Lamar County Community Service Coordinator RETIRING MARCH 31, 2017



Jimmy Don Nicholson, HTR, is the Lamar County Community Service Coordinator. His 2005 published research in the Journal of Therapeutic Horticulture Volume XVI / American Horticultural Therapy Association www.ahta.org is a great contribution to field of Horticultural Therapy and Criminal Justice. His studies and programs reveal that performing Community Service Restitution helps reduce recidivism amongst probationers, and when combined with community service duties involving plant material, the reduction in recidivism increased another twenty-three percent. Jimmy Nicholson's quantitative/quality work extended him opportunities to present the Lamar County Adult Probation Department's Horticultural Therapy Program as far east as Washington D.C., in the battleground states of Maryland and Kentucky, and to state officials in Rhode Island. He did not stop there, however, as he was also asked to present in Kansas and Colorado, and then westward all the way to San Francisco, California. He, with great pride, also presented these findings to numerous audiences in our great State of Texas. Dr. Richard Mattson, Dr. C A Dempsey, and the late Judge Jim D. Lovett, are just a few among the notable contributors of this horticultural therapy research.

Jimmy is a leader of people, an effective organizer, and a person who is truly interested in helping people help themselves. He is a Christian family man and a decorated military veteran, who proudly served his country as a member of the United States Air Force, from which he later received an Honorable Discharge upon his departure. He is a retired member from the Blacksmiths and Boilermakers Union-Local 902, a rancher, a researcher, a Texas Master Gardener and a Registered Horticultural. He plans to continue to serve on the board for Keep Paris Beautiful/Make Lamar County Shine and on the Northeast Texas Trail Coalition board of directors http://northeasttexastrail.org/. Jimmy served as Chairman of the Board to the Valley of the Caddo Museum and Cultural Center helping develop it from just an idea to its opening. He, to this day, is very proud to have had the opportunity to be a part of bringing this Museum to the Lamar County area https://www.facebook.com/Valley-of-the-Caddo-Museum-Cultural-Center-Inc-630060587047936/. While working as a boilermaker for Babcock and Wilcox, Jimmy played an instrumental part in the organizing of volunteer labor (his own labor included) in the building of the Paris Texas Eiffel Tower (the Eiffel Tower with the big red cowboy hat on top). https://www.paristexas.gov/
